Assembly Bill (AB) 74 (Chapter 74, Statutes of 2019) appropriated a total of \$60M Total Funds (\$30M General Fund) from July 1, 2019 through June 30, 2022. Augmented funding was received via Senate Bill (SB) 154 (Chapter 43, Statutes of 2022), resulting in an additional \$60M Total Funds (\$30M General Fund) from July 1, 2022 through June 30, 2026.

Due to the second appropriation to continue these Health Enrollment Navigators Project efforts, DHCS extended AB 74 activities for one additional quarter (July - September 2022) to allow partners additional time to fully utilize any unspent allocations while concurrently assessing bids and making funding awards for SB 154. The award notices and agreements were sent to partners in September 2022 so that work efforts could continue in October 2022, without a break in these critical services.

The following information is needed to contextualize the data as it is read in this Project Summary report:

- Demographics information reported (i.e. sex, age, etc.) were gathered from their MEDS profile(partners provided DHCS with social security number and/or client identification numbers for each individual reported as enrolled and retained)
- Enrollment and retention submissions have been scrubbed for duplications within a fiscal year; however, some individuals can be encountered and assisted multiple times throughout the course of the AB 74 Project
- Outreach data encompasses both face-to-face and mass/social media; information is understood to be duplicative based on the way it was collected and reported (SB 154 has split outreach from mass/social media to provide more transparent information)
- "*" indicates cell suppression for cell values less than 11; "**" indicates complimentary cell suppression.
- Not all partners started and completed at the same times, due to processes around obtaining Board of Supervisors' approvals, Project budgets, and uncertainties created to the nature of the COVID-19 Public Health Emergency
- The totals for each table vary due to not all data fields and/or demographic information being reported by contracted partners.
