Maaih yietc diuc se benx jaa benx zanv souz mouc yiem zornc nyaanh gorn liouh bun taux mienh goz, m'zing wuaaic, aengx caux guov zangc hungh jaa capv cuotv ndorqc mangc mienh jomc wuaaic fangx kou-gong gorn (Aged, Blind & Disabled Federal Poverty Level) (ABD FPL) kou-gong gorn. Corc maaih da'nyeic diuc haih zoux bun naaiv deix mienh laaih zitc puix-zipv gauz liouh tengx ABD FPL kou-gong gorn se dungh haaix zanc saengv zangc bun nyaanh daaih tengx ninh mbuo nyei Medicare Part B jaaz wuov. Haaix deix mienh dungh zinh ndaangc nziouv hnoi mv maaih ze'buonc horpc wuov se haih duqv wang-henh longc Medi-Cal jiex gorn yiem naaiv **Ziepc nyeic hlaax saengh 1, 2020.**

Paaiv benx siang nyei buonc zoqc zanv souz mouc zornc nyaanh hlaax se funx yiem naaiv a'fai gauh aiv \$1,488 liouh yietc dauh mienh nyei buonc, a'fai \$2,003 liouh benx yi dauh cai-doiz, dungh meih duqv maeqv cuotv longc nyei buonc liuz. Meih corc haih maeqv cuotv beu weih heng-wangc sou-gorn jaaz, lemh jienv Medicare Part B nyaanh, mv gauh zoqc jiex ndaam-buonc ei zornc nyei buonc nyaanh, aengx caux longc zouz gong nyei buonc.

Beiv taux meih maaih ze'buonc puix horpc nzoih naaiv diuc siang nyei zoqc zanv souz mouc nyaanh, nzunc baav meih haih maaih puix-zipv gauz liouh duqv wang-henh longc Medi-Cal se gorngv ih zanc meih cuotv nyaanh:

- Ziux hlaax cuotv nyei buonc nyaanh jaaz liouh benx 250 ber sen zouz gong gan wuaaic fangx kou-gong gorn (250 Percent Working Disabled program), **a'fai**
- Cuotv nyaanh jaaz liouh benx da'nyeic diuc sou-gorn tengx beu weih heng-wangc.

Meih corc aengx haih maaih puix-zipv gauz tengx beiv taux meih duqv juangc bieqc 250 ber sen zoux gong wuaaic fangx kou-gong gorn (250 Percent Working Disabled Program) liouh mbungh simv cuotv mv zuqc juangc cuotv jaaz.
