

## **Presumptive Eligibility for Pregnant People Qhov Kev Pab Cuam Neeg Mob Tsab Ntawv Teev Cov Lus Uas Qhia Qhov Tseeb**

### **Presumptive Eligibility for Pregnant People (PE4PP) yog dab tsi?**

PE4PP yog ib qhov kev pab cuam uas muaj kev pab ib ntus cuam tshuam rau cov poj niam uas lub cev tsis tab seeb rau cov tib neeg uas tau nyiaj los tsawg. Qhov kev pab cuam yuav them cov nqi ntawm:

- Cov kev mus ntsib kws kho mob, cov kev mus kuaj mob, thiab cov kev mus kho mob hauv chav kho cov mob uas yuav tsum tau kho tam sim ntawd
- Cov tshuaj vitamins uas siv thaum lub cev tsis tab seeb thiab cov tshuaj feem ntau
- Cov kev saib xyuas rau thaum tus me nyuam poob lawm thiab thaum muab tus me nyuam nrho lawm

PE4PP yuav tsis them nqi tsev kho mob thiab nqi saib xyuas thaum mus yug me nyuam thiab los sis lwm cov teeb meem uas yuav tau mus pw hauv tsev kho mob. Yog xav tau kev pab them nqi yug me nyuam, koj yuav tsum tau mus thov Medi-Cal.

PE4PP yog ib qhov kev pab cuam uas muaj kev pab tam sim, muaj kev pab ib ntus rau cov kev kho mob cuam tshuam rau cov poj niam cev tsis tab seeb rau cov neeg uas tau nyiaj los tsawg, suav nrog rau nqi rho me nyuam thiab nqi saib xyuas thaum tus me nyuam poob lawm. Qhov kev pab cuam yeej them feem ntau ntawm cov nqi mus ntsib kws kho mob, mus kuaj mob, thiab mus kho mob hauv chav kho cov mob uas yuav tsum tau kho tam sim ntawd. Qhov kev pab cuam yeej them tus nqi ntawm cov tshuaj vitamins uas siv thaum lub cev tsis tab seeb thiab cov tshuaj feem ntau. PE4PP yeej TSIS them tus nqi tsev kho mob thaum mus yug me nyuam thiab tus nqi saib xyuas thaum yug me nyuam los sis lwm yam teeb meem uas yuav tau mus pw kho nyob hauv tsev kho mob. Koj yuav tsum muab ib tsab ntawv thov Medi-Cal xa mus thov es

qhov kev pab cuam thiaj li yuav pab them tus nqi thaum mus yug me nyuam thiab tus nqi ntawm kev saib xyuas thaum mus yug me nyuam.

### **Leej twg thiaj li yuav tsim nyog siv tau PE4PP?**

Koj yeej tsim nyog siv tau yog:

- Koj xav hais tias koj lub cev tsis tab seeb
- Koj tsev neeg cov nyiaj tau los yeej yog tau tsawg tshaj li ib qhov nyiaj

Peb yeej muab cov poj niam cev tsis tab seeb suav hais tias yog ob los sis ntau tshaj ob tus neeg nyob hauv tsev neeg, nyob ntawm saib cov me nyuam uas tseem nyob hauv plab yog muaj pes tsawg tug. Qhov kev pab them nqi yeej yog pib thaum hnub ua koj mus tso npe siv.

### **Kuv yuav uas li cas es kuv thiaj li yuav mus thov tau PE4PP?**

Koj yuav tsum tau mus thov ntawm ib tus kws kho mob uas peb muab hu ua Qualified Provider (kws kho mob los sis chaw kuaj mob uas muaj qhov kev pab cuam PE4PP).

### **Kuv yuav tau qhov kev pab them nqi los ntawm PE4PP ntev npaum li cas?**

Koj qhov kev pab them nqi los ntawm PE4PP yuav pab them koj cov nqi mus txog thaum koj tsab ntawv thov kev faj seeb rau kev kho mob (zoo li Medi-Cal) twb tau los sis tsis tau txais lus pom zoo lawm. Koj yuav tsum tau mus thov Medi-Cal es koj thiaj li tseem yuav siv tau koj qhov kev pab them nqi. Yog koj tsis mus thov, koj qhov kev pab them nqi kho mob yuav tag rau lub hlis tom ntej ntawd.

- Yog hais tias PE4PP yeej tsis them tus  
nqi ntawm ib qhov kev pab los sis kev  
kho mob, Medi-Cal ntxim yuav them—  
tiam sis koj yuav tsum tau mus thov tsis  
txhob pub dhau peb lub hlis ntawm hnub  
uas koj tau mus kho mob (tsis yog hnub  
uas muaj nyob ntawm daim nqi).
- Thaum sau koj tsab ntawv thov Medi-  
Cal, teb hais tias "yes" rau nqis lus nug  
hais txog nqi kho mob nyob hauv peb  
lub hlis tag los no, txawm hais tias koj  
yeej tseem tsis tau ib daim nqi li.
- Yog koj tus me nyuam poob lawm los  
sis koj yuav tsis siv qhov kev pab them  
nqi lawm, koj yeej tseem tsim nyog mus  
thov Medi-Cal thiab khij qhov hais tias  
"yes" rau qhov kev pab them nqi hauv  
peb lub hlis.
