SUBJECT: TIME LIMITED ELIGIBILITY OF REFUGEE MEDICAL ASSISTANCE

FOR IRAQI AND AFGHAN IMMIGRANTS GRANTED SPECIAL IMMIGRANT STATUS UNDER SECTION 101 (a)(27) OF THE

IMMIGRATION AND NATIONALITY ACT (INA)

The purpose of this letter is to inform the county welfare departments about new federal rules on the eligibility of Iraqi and Afghan Special Immigrants (SIs) for Refugee Medical Assistance (RMA) benefits and the time limit of such eligibility. Effective December 26, 2007, eligible Iraqi and Afghan SIs are entitled to time limited RMA. Afghan SIs are eligible for up to six months of RMA and Iraqi SIs are eligible for up to eight months of RMA, at which time RMA eligibility ceases.

WHO IS COVERED?

According to Section 525 of Title V of Division G of Public Law 110-161 (The Consolidated Appropriations Act, 2008); "Iraqi and Afghan aliens granted special immigrant status under section 101(a)(27) of the Immigration and Nationality Act (INA) shall be eligible for resettlement assistance, entitlement programs, and other benefits available to refugees admitted under section 207 of such Act for a period not to exceed

six months." This section was partially superseded by Section 1244 of Public Law 110-181 (National Defense Authorization Act, 2008) which states: "Resettlement Support - Iraqi aliens granted special immigrant status descried in section 101(a)(27) of the Immigration and Nationality Act...shall be eligible for resettlement assistance, entitlement programs, and other benefits available to refugees admitted under section 207 of such Act (8 U.S.C. 1157) for a period not to exceed *eight months*." (Emphasis added). In no case can eligibility begin prior to December 26, 2007, because the Consolidated Appropriations Act was signed into law on that date.

PERIOD OF ELIGIBILITY

Afghan SIs: The six-month clock on RMA eligibility for Afghan SIs and their eligible family members that established their SI status prior to arriving in the U.S. (the consular process) begins on the date that they are admitted to the U.S. as an Afghan SI. For Afghans adjusting to SI status domestically (within the U.S.) from some other immigration status such as visitor or student, the six month RMA clock begins on the date of grant of Lawful Permanent Resident (LPR) status. The date LPR status is granted is typically based on the earlier grant of Afghan Special Immigrant status. No additional services will be provided for the months of eligibility that occurred prior to the effective date of the law, December 26, 2007, or prior to application for RMA benefits.

Example: An Afghan SI who arrives in the U.S. on March 1, 2008, and first applies for RMA on May 1, 2008, is eligible to receive benefits only from the date of application to August 31, 2008, six months after the date of entry to the U.S. as an Afghan SI.

Iraqi SIs: The eight-month clock on RMA eligibility for Iraqi SIs and their eligible family members that established their SI status previous to arriving in the U.S. (the consular process) begins on the date that they are admitted to the U.S. as an Iraqi SI. For Iraqis adjusting to SI status domestically (within the U.S.) from some other immigration status such as visitor or student, the eight-month RMA clock begins on the date of grant of LPR status. The date LPR status is granted is typically based on the earlier grant of Iraqi Special Immigrant status. No additional services will be provided for the months of eligibility that occurred prior to the effective date of the law, December 26, 2007, or prior to application for RMA benefits.

Example: An Iraqi SI who arrives in the U.S. on March 1, 2008, and first applies for RMA benefits on May 1, 2008, is eligible to receive benefits only from the date of application to October 31, 2008, eight months after the date of entry to the U.S. as an Iraqi SI.

DOCUMENTATION

Counties will be required to determine eligibility in accordance with current RMA eligibility requirements. This eligibility determination includes confirmation of the individual's immigration status and date of entry through verification of appropriate documentation. The following documents will confirm both immigration status and date of entry for Iraqi and Afghan SIs:

ELIGIBILITY REQIREMENTS

Iraqi and Afghan SIs must meet all RMA eligibility requirements. For example, current policy for RMA eligibility is that applicants must be determined ineligible for California Opportunity and Responsibility to Kids, Healthy Families, and Supplemental Security Income/State Supplementary Payment - based Medi-Cal or Medi-Cal Only before they can be placed in RMA (Medi-Cal Eligibility Procedures Manual Section 24B (2)). The same is true with Iraqi and Afghan SIs.

NOTICES OF ACTION (NOAs)

The Department of Health Care Services (DHCS) has created NOAs for Iraqi SIs, and for Afghan SIs. The notices address the differences in the length of eligibility for the two SI types, Afghan and Iraqi. These NOAs are attached to this All County Welfare Directors Letter (ACWDL). Numbers will be assigned to the NOAs in a future ACWDL. Please send these NOAs and a Medi-Cal application at least 60 days prior to the termination of RMA benefits for these SIs as detailed in ACWDL 08-43.

SYSTEM CHANGES

DHCS is in the process of developing the necessary Medi-Cal Eligibility Data System (MEDS) coding for these new RMA eligible immigrants. If any refugees are identified as eligible for this program please use the existing RMA aid code and track the cases for time limitations until further notice. Counties must track all Iraqi and Afghan SIs who are put into MEDS so that MEDS coding can be updated in the future and so that the six month time-limited eligibility for Afghan SIs can be tracked and their eligibility can be manually terminated at the end of their period of eligibility.

TERMINATION OF RMA BENEFITS

Iraqi SIs: DHCS will implement MEDS generated terminations for RMA benefits reaching the federal eight-month time limit. The automatic termination process is detailed in ACWDL 08-43.

Afghan SIs: Until further notice manual terminations with all NOA requirements will be necessary for Afghan SIs temporarily placed in the existing RMA aid code, since they have a six-month (rather than an eight-month) time limit on eligibility. DHCS will notify counties in a separate ACWDL when MEDS programming is updated to send alerts for Afghan SIs nearing the end of their six-month eligibility period and automatically terminate RMA eligibility after six months for Afghan SIs.
