**NEW WAIVER REFERRALS FROM THE REGIONAL CENTERS**

Ref.: ACWDL Nos. 99-10 and 99-26

This letter is to inform counties that Health Care Financing Administration has lifted the moratorium on the Department of Developmental Services (DDS) Home and Community Based waiver referrals for children under the age of 18 living at home with their families who are not currently eligible for zero share-of-cost Medi-Cal.

Regional Center referral forms may include a cover letter requesting three months of retroactive eligibility which is allowable per Section 50710 of the California Code of Regulations if the applicant meets the conditions of that section.

Counties may wish to review the Medi-Cal Eligibility Procedures Manual Article 19D for further information.
