SUBJECT: EXTREME WEATHER DECEMBER 2008 ALERT

This is to advise County Welfare Departments (CWDs) to begin preparations for possible assistance from County Medi-Cal Eligibility staff in the event of activation of California Mobile Assistance Centers.

The National Weather Service has advised that a severe cold front is anticipated to hit California as early as December 12, 2008. Temperatures are expected to be 15-20° below seasonal averages throughout the State, with the snow levels at low elevations in mountain ranges. The California Department of Public Health (CDPH) and the Department of Health Care Services (DHCS) are implementing Phase I of the California Contingency Plan for Extreme Cold/Freeze Emergencies.

As part of DHCS preparedness activities, CWDs are being advised that if there is a need to activate California Mobile Assistance Centers, CWDs will need to make Medi-Cal Eligibility staff available to work at these centers. The California Mobile Assistance Centers are one stop centers that provide job and unemployment assistance, support with food programs, health care information, warming center location information and other essential services.

Activation of California Mobile Assistance Centers requiring Medi-Cal Eligibility staff would not occur unless we enter Phase III, at which time an assessment of need will be made and affected CWDs will be notified and details will be made available.
