Activity or Program Description: Butte County Public Health Department (BCPH) used Opioid Settlement funds to continue and enhance surveillance activities. BCPH uses Overdose Detection Mapping Application Program

tool (ODMAP) and the California Overdose Surveillance dashboard to inform department & coalition interventions. ODMAP provides near real time suspected overdose data collected from Public Safety partners. ODMAP is not available to the public and is limited to government agencies, therefore BCPH plays a key role in surveillance efforts in the county.
