TO: ALL LOCAL COUNTY CALIFORNIA CHILDREN SERVICES (CCS) PROGRAM AND GENETICALLY HANDICAPPED PERSONS PROGRAM (GHPP) STAFF, CCS MEDICAL CONSULTANTS, COUNTY MEDICAL STAFF, AND INTEGRATED SYSTEMS OF CARE DIVISION (ISCD) STAFF

SUBJECT: UPDATES TO CONTRACTED MEDICAL SUPPLIES, INCONTINENCE SUPPLIES, AND ENTERAL NUTRITION PRODUCTS

The purpose of this Information Notice is to communicate that effective retroactively back to December 1, 2017, updates to lists of contracted medical supplies, incontinence supplies, and enteral nutrition products will cease to be communicated through CCS Information Notices or This Computes.

It has come to the attention of Integrated Systems of Care Division that Service Authorization Request (SAR) adjudicators are using copies of old and out-dated lists of contracted items and changes to contracted products that were published in the past, via This Computes or CCS Information Notices. In some instances, these changes occurred years ago and are no longer valid.

CCS SAR adjudicators and GHPP SAR staff should review the latest lists for each contracted product category which are posted online in the Medi-Cal Provider Manual.
