

Overview

Below, find a scoring rubric for Submission 2 of the BH-CONNECT Access, Reform and Outcomes Incentive Program.

Incentive program measures reflected in this submission include:

- » Measure 13: Demonstrate Improved Data Sharing for the Behavioral Health Population
- » Measure 14: Improve Identification and Outreach to Member Population Eligible for Specialty Behavioral Health Services
- » Measure 15: Increase Capacity to Deliver Crisis Services

Submission 2 responses will be graded based on how well the BHP demonstrates they are working towards identified priorities (e.g., if they are demonstrating they are actively working to share data), and the completeness/level of detail of their response.

Table 1 below provides an overview of the total available points for each measure that is part of Submission 2. The subsequent tables include specific scoring parameters for each question.
