2. All Other Service Providers - a provider's place of service (actual location where most services are being provided or where the clinician's office is located).

The DMH will initiate the Provider File changes and will assist all affected counties to ensure that individual county provider issues relating to these Legal Entities are resolved. Counties must consult with the DMH prior to submitting any Provider File Updates specific to these three Legal Entities. Carla Minor, Provider File Specialist, will fax Provider File Update (PFU) forms to the Provider File contact person, and will work with county staff to ensure that changes are made as appropriate.
