PROPOSED STATE PLAN AMENDMENT TO EXEMPT MEDI-CAL FEE-FOR-SERVICE PROVIDERS OF DURABLE MEDICAL EQUIPMENT COMPLEX REHABILITATION TECHNOLOGY AND COMPLEX REHABILITATION TECHNOLOGY SERVICES FROM A STATUTORY TEN PERCENT PAYMENT REDUCTION

This notice provides information of public interest regarding a proposed State Plan Amendment (SPA) by the Department of Health Care Services (DHCS). DHCS plans to submit proposed SPA 21-0064 to the Federal Centers for Medicare & Medicaid Services (CMS) to exempt Durable Medical Equipment Complex Rehabilitation Technology (DME CRT) and Complex Rehabilitation Technology Services (CRTS) from the Assembly Bill (AB) 97 ten percent payment reductions, effective January 1, 2022.

Pursuant AB 97 (Chapter 3, Statutes of 2011), and Welfare and Institutions Code (WIC) section 14105.192, Medi-Cal fee-for-service benefits are subject to payment reductions of no more than 10 percent for dates of service on and after June 1, 2011.

The Public Health Omnibus bill of 2021, AB 133 (Chapter 143, Statutes of 2021), amended WIC section 14105.192, to exempt Medi-Cal providers of DME CRT and CRTS from the AB 97 ten percent payment reductions, for dates of service on or after January 1, 2022. DHCS will seek approval for this exemption in SPA 21-0064.

Proposed SPA 21-0064 is subject to approval by CMS.

DHCS estimates that the annual aggregate Medi-Cal expenditures for DME CRT and CRTS will increase by approximately \$2 million in total funds.
