**PROPOSED STATE PLAN AMENDMENT TO
ESTABLISH A REIMBURSEMENT RATE FOR THE COGNITIVE HEALTH
ASSESSMENT BENEFIT**

This notice provides information of public interest regarding a proposed State Plan Amendment (SPA) by the Department of Health Care Services (DHCS). The proposed SPA 22-0046 is seeking federal authority to establish a reimbursement rate for the cognitive health assessment benefit, effective July 1, 2022. DHCS requests input from beneficiaries, providers, and other interested stakeholders concerning proposed SPA 22-0046, which is attached to this notice.

DHCS is developing the Dementia Aware initiative to establish a statewide provider training program in culturally competent dementia care, as well as establish a referral protocol on cognitive health and dementia for Medi-Cal beneficiaries. In alignment with the Dementia Aware initiative, Senate Bill (SB) 48 (Chapter 484, Statutes of 2021) added Section 14132.171 to the Welfare and Institutions Code to establish annual cognitive health assessment as a Medi-Cal covered benefit. The annual cognitive health assessment will be available to Medi-Cal beneficiaries, 65 years of age or older, who are otherwise ineligible for a similar annual cognitive health assessment through the Medicare program.

The effective date of the proposed SPA is July 1, 2022. For dates of service on or after July 1, 2022, DHCS will establish the reimbursement rate for the cognitive health assessment at \$29.00.

DHCS estimates that the increase in annual aggregate Medi-Cal expenditures for the cognitive health assessment will be approximately \$595,000 in total funds.

SPA 22-0046 is subject to approval by the Federal Centers for Medicare and Medicaid Services (CMS).

PUBLIC REVIEW AND COMMENTS

The proposed additions included in draft SPA 22-0046 are enclosed in this notice for public comment. DHCS is requesting stakeholder input on the impact, if any, on access to services as a result of the proposed action.

REIMBURSEMENT METHODOLOGY FOR COGNITIVE ASSESSMENT

1. Notwithstanding any other provision in this Attachment, the Department of Health Care Services (DHCS) will establish the Medi-Cal reimbursement rate for the annual cognitive assessment benefit for the Dementia Care Aware program, as authorized in Attachment 3.1-A, section 13c, using the following methodology:
 - a. For dates of service on or after July 1, 2022, the reimbursement rate will be \$29.00.
 - b. The ten percent payment reduction, described in paragraph (13) on page 3.3 of this Attachment, shall apply to the services described in this section if billed by a non-exempt provider, as described in paragraph (16) on page 3.4 of this Attachment.
