PROPOSED STATE PLAN AMENDMENT TO UPDATE INTERGOVERNMENTAL TRANSFER FUNDED PAYMENTS FOR THE SUPPLEMENTAL REIMBURSEMENT FOR QUALIFIED PRIVATE HOSPITALS FOR STATE FISCAL YEAR 2023-24

This notice is to provide information of public interest about a proposed State Plan Amendment (SPA) by the Department of Health Care Services (DHCS). Fountain Valley Regional Hospital was acquired by the University of California, Irvine Health System on March 28, 2024, and will no longer be a private hospital and meet program eligibility requirements. Proposed SPA #24-0027 proposes to update Intergovernmental Transfer (IGT) funded payments for State Fiscal Year (SFY) 2023-24. Below are the proposed updated payment amounts for SFY 2023-24.

Fountain Valley Regional Hospital's ineligibility under the program results in increased payments for Children's Hospital of Orange County, Anaheim Global Medical Center, Orange County Global Medical Center, South Coast Global Medical Center, and Garden Grove Hospital and Medical Center. DHCS estimates that the annual aggregate Medi-Cal



expenditures for inpatient hospital services will be \$58,382,187.73 in total funds, a reduction of \$487,181.60 from approved SPA #23-0013.

The effective date of the proposed SPA is April 1, 2024. All proposed SPAs are subject to approval by the Centers for Medicare and Medicaid Services (CMS).
