

Dual Eligible Special Needs Plans (D-SNPs) and D-SNP Enrollment in California (April 2023)

D-SNPs serve members in numerous counties across California. Some D-SNPs are operated by parent plans that also have a Medi-Cal line of business within the same county. The table below displays D-SNP enrollment figures by county as of April 2023. These enrollment numbers include exclusively aligned D-SNPs, non-exclusively aligned D-SNPs, and SCAN FIDE-SNPs. In cases where enrollment numbers are listed without an associated plan members have a Medi-Cal address in a different county than their Medicare address.
