## Medi-Cal Dental Program Updates

#### **DMC Procurement**

- The Dental Managed Care (DMC) Request for Proposal (RFP) has been released on August 3, 2023.
- » Proposals due by 4 p.m. on October 6, 2023.
- » Anticipated contract execution date is January 2024 with operations to begin on August 1, 2024.

#### **Dental Transformation Initiative**

- » An additional Domain 1 and Domain 3 payment was issued in July 2023.

#### **1915b Waiver Monitoring Requirements**

- » Data to evaluate the utilization between FFS and DMC in the following metrics:
  - Annual Dental Visits
  - Use of Preventive Services
  - Use of Sealants
  - Medi-Cal Dental Reports
- » Data necessary to monitor health outcomes and quality metrics at the local and aggregate level
- » Data necessary to monitor appeals and grievances for beneficiaries
- » CalAIM 1915(b) Waiver Special Terms and Conditions



#### Proposition 56 Supplemental Payments as of May 31, 2023




### Teledentistry

Modality for the provision of select dental services, which can be rendered via CDT Codes D9996 (asynchronous store-andforward) and D9995 (synchronous live transmission encounter).




#### **Community Health Workers (CHW)**

- » DHCS is working to implement a CHW policy for Medi-Cal Dental.
- » The policy will align with the Medi-Cal CHW policy implemented July 1, 2022.



#### Children's Presumptive Eligibility (CPE)

Specified Medi-Cal providers will be eligible to participate, including Dentists. Providers will have to meet qualification standards to become qualified PE providers.



#### **CDT-23**

- » Effective April 1, 2023, the following CDT codes were included in CDT-23:
  - D6105 (Removal of implant body)
  - D7251 (Coronectomy)
- » Effective May 1, 2023, the following CDT codes were included in CDT-23:
  - D9995 & D9996 (Teledentistry)
