The Medi-Cal Dental Program enrolled about 15.5 million members in June 2023:

92% Fee-For-Service (FFS),
7% Dental Managed Care (DMC) consisting of Geographic Managed Care (GMC) plans in Sacramento County and Prepaid Health Plans (PHP) in Los Angeles County,
1% Health Plan of San Mateo (HPSM)

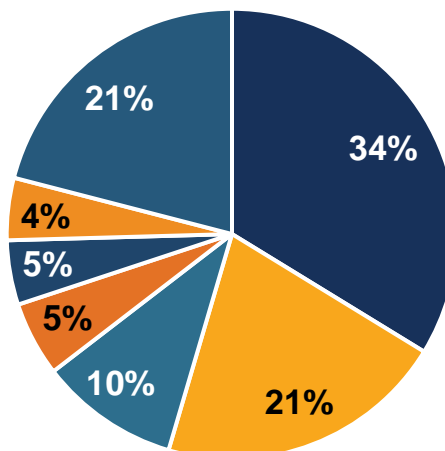

Language Line Service (LLS) Call Volume

253,637 - Member calls were received from January to March 2023 in the FFS and DMC delivery systems including the LLS call volume.

LLS call breakdown from the member call volume:

- 10,467 LLS calls were requested
- 3,922 (37%) FFS LLS calls
- 6,545 (63%) DMC LLS calls
- 59 languages were requested
- 79% of LLS calls are comprised of 6 languages as shown in the pie chart
- 21% are comprised of various other languages.

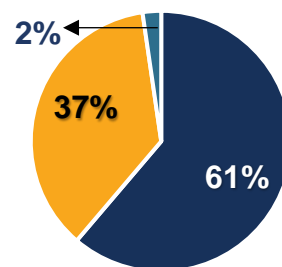

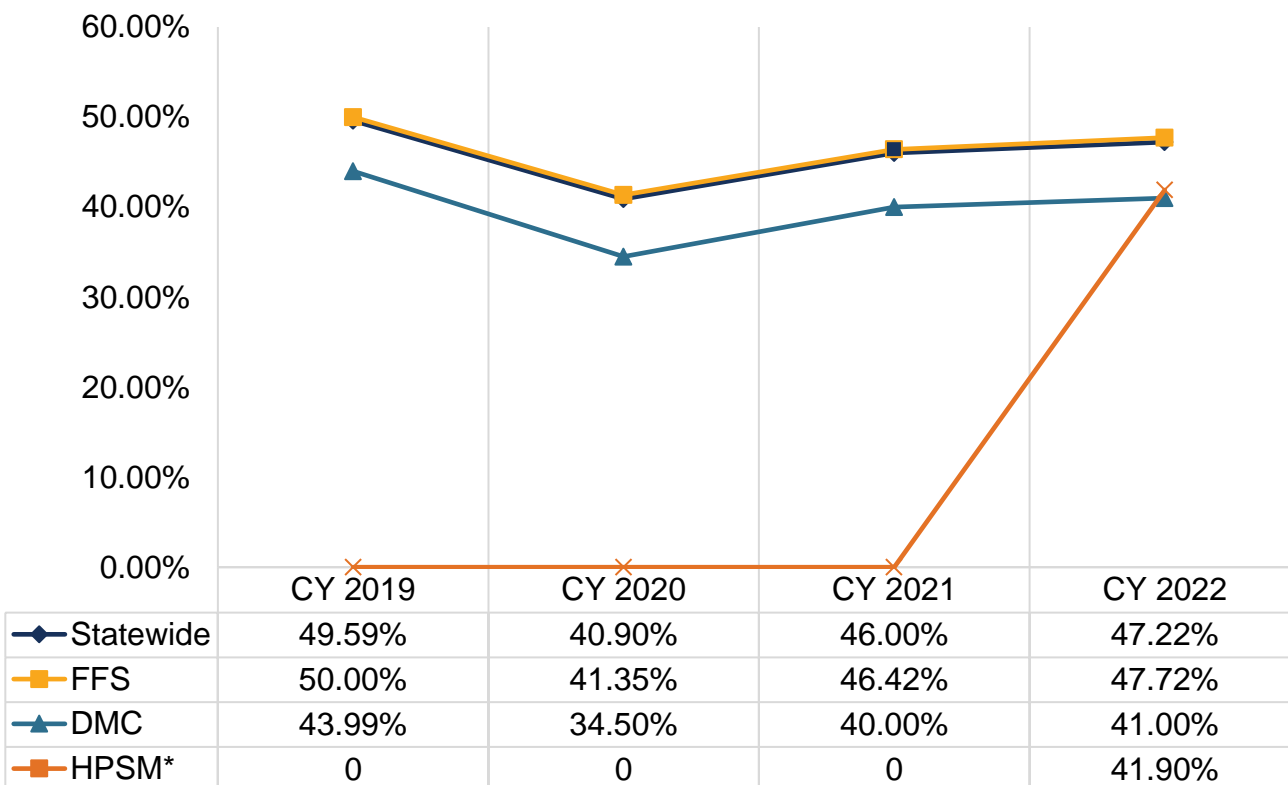

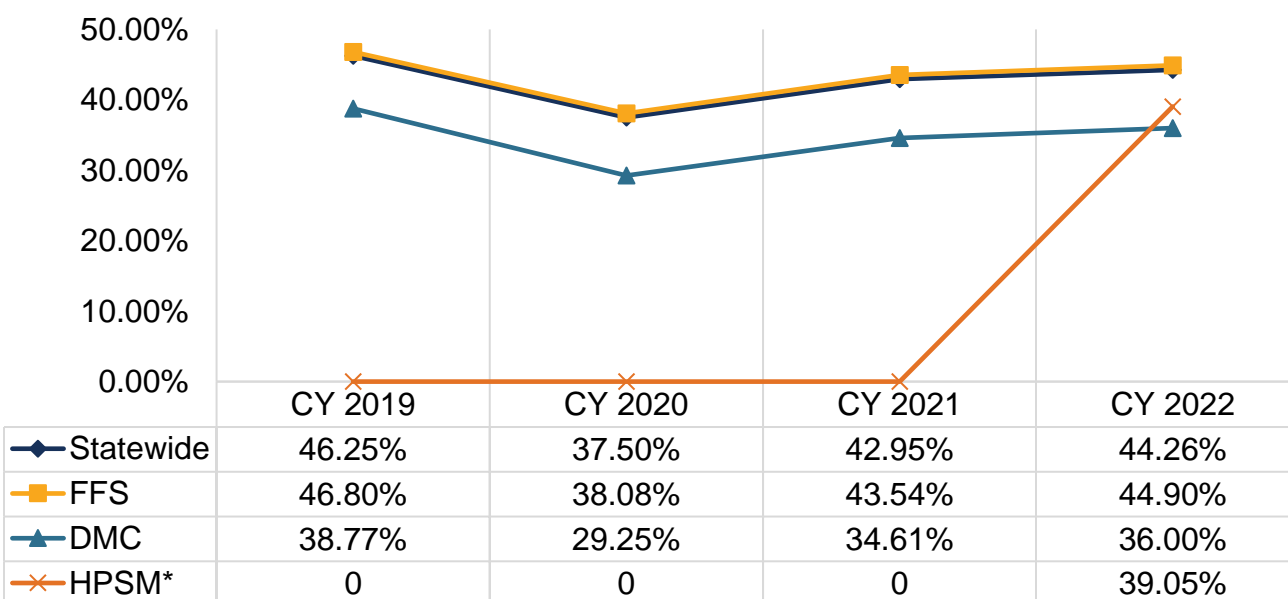
Utilization in Ages 0-20

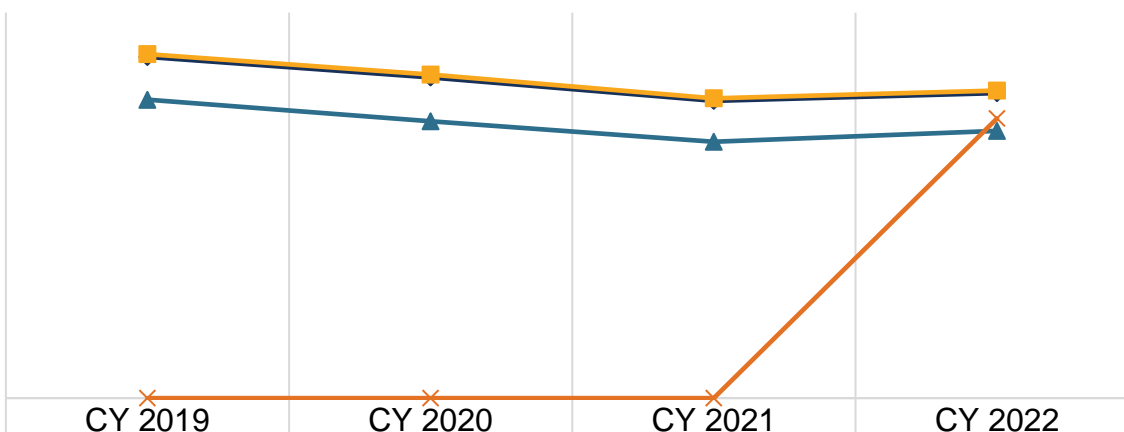

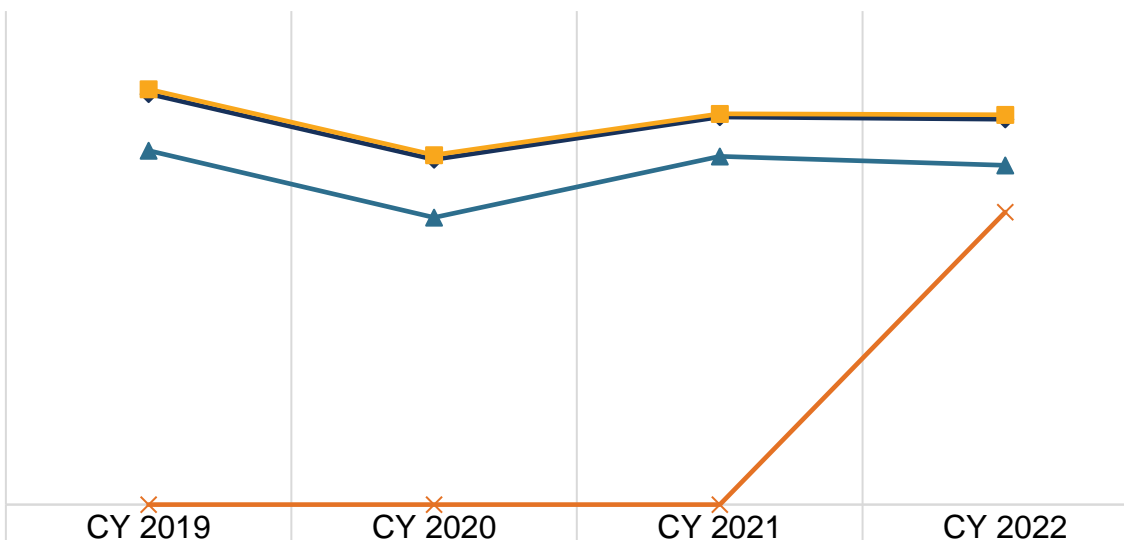

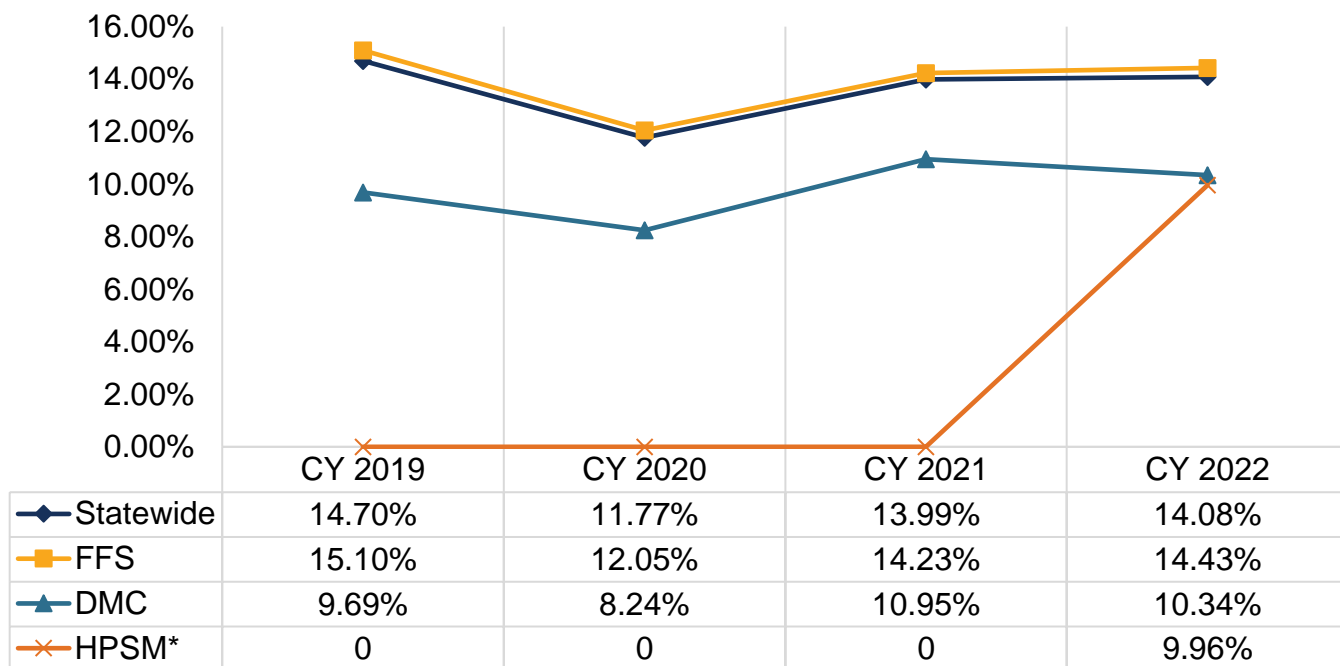

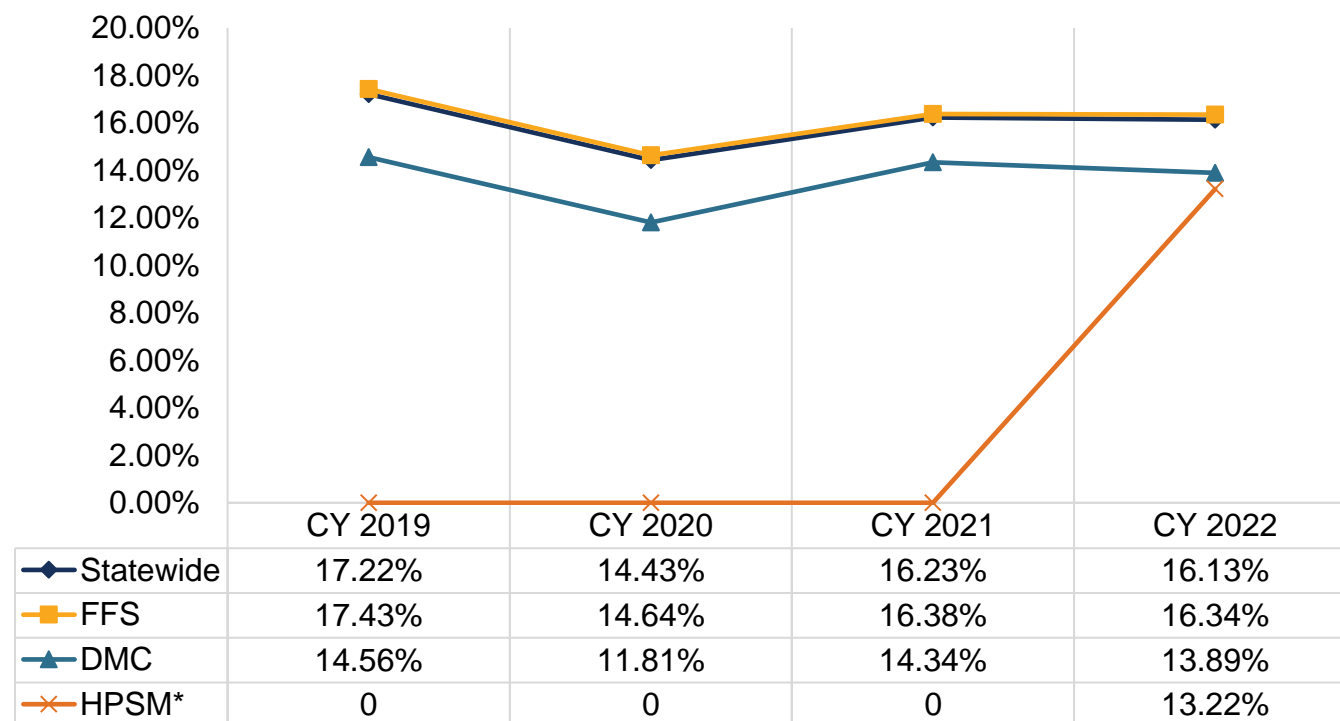

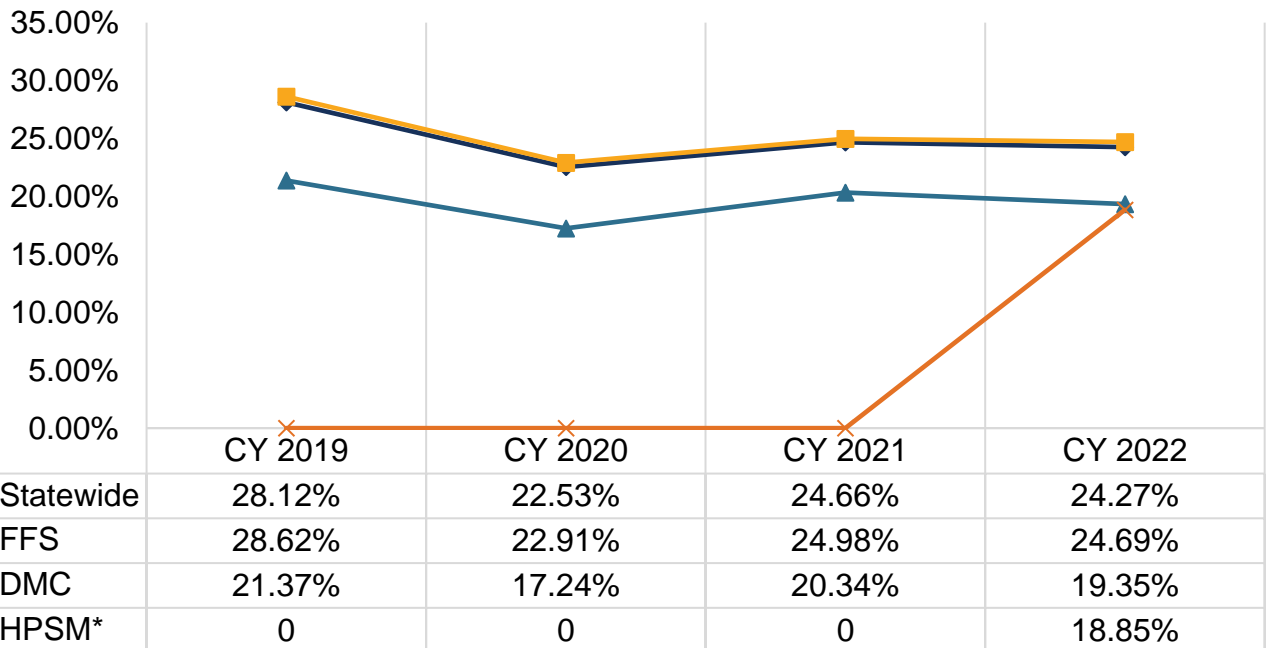

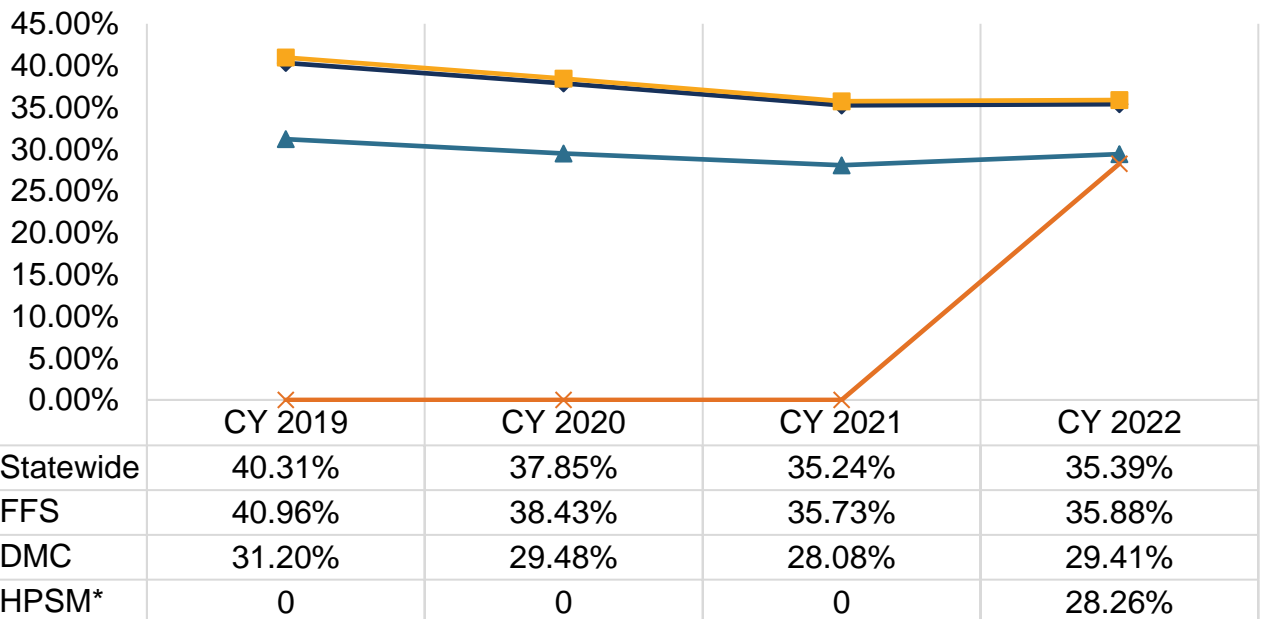
