



Cultural and Linguistic Demographics of the California Medicare Population

Understanding Medicare and Dual Eligibility

- » **Medicare** – Federal health insurance program for:
 - Most people who are 65 or older
 - Certain younger people with disabilities
 - Certain people with End-Stage Renal Disease
- » **Dual Eligible Beneficiary** – A Medicare beneficiary who is also a beneficiary of Medi-Cal (Medicaid)
 - Medi-Cal (Medicaid) – State-operated health insurance program for individuals with low incomes, among others
- » **Medicare-Only Beneficiary** – A Medicare beneficiary without Medi-Cal (Medicaid) coverage

Nationwide Medicare and Medicaid enrollment, 2022



Californians with Medicare in 2019

- » The federal Medicare program served an estimated 6.2 million Californians in 2019
- » In California, among Medicare beneficiaries:
 - 87% were age 65 or older
 - 26% reported having Medi-Cal coverage
 - 15% had limited English proficiency
 - 32% were born outside the U.S.




California Medicare Beneficiaries Had Diverse Racial and Ethnic Identities

One-Third of California Dual Beneficiaries Had Limited English Proficiency


Limited English Proficiency, Percent of Medicare Population



Note: "Dual" means dual eligible beneficiaries covered by both Medicare and Medi-Cal (or Medicaid outside of California).


Diverse Languages Spoken by California Medicare Beneficiaries

Half of California Dual Beneficiaries Were Born Outside the U.S.


Born Outside the U.S., Percent of California Medicare Beneficiaries



Note: "Dual" means dual eligible beneficiaries covered by both Medicare and Medi-Cal (or Medicaid outside of California).


Birthplace Varied by County in California

Birthplace of Those Born Outside the U.S.



Individuals born outside the U.S. are a very diverse group. This population includes those who have immigrated in different eras and at different ages, with varied naturalization status, cultures, and levels of English proficiency.

Conclusion

Among California's 6.2 million Medicare beneficiaries in 2019:

- **Racial and ethnic diversity was greater** than for Medicare beneficiaries nationwide.
- **15% had limited English proficiency**, more than for Medicare beneficiaries nationwide.
 - **Dual beneficiaries had limited English proficiency more** (33%) than Medicare-only beneficiaries (8%).
 - **Counties differed widely in the percent with limited English proficiency** for both dual and Medicare-only beneficiaries.
- **32% were born outside the U.S.**, more than for Medicare beneficiaries nationwide.
 - **Dual beneficiaries were born outside the U.S. more** (49%) than Medicare-only beneficiaries (26%).
 - **Counties differed widely in the percent born outside the U.S.** for both dual and Medicare-only beneficiaries.






Californians Near Medi-Cal Income Eligibility Had an Annual Income of ~\$22,000

Annual Median Per-Person Income of Age 65+ California Medicare Beneficiaries (in 2023 Dollars), by Income Bracket




Compared to Those with Higher Incomes, Near Medi-Cal Income Eligible Beneficiaries Were **More Likely to be Female and Older than 85**

Percent of Age 65+ California Medicare Beneficiaries Female Sex, by Income Bracket




Age Group of Age 65+ California Medicare Beneficiaries, by Income Bracket




Compared to Those with Higher Incomes, Near Medi-Cal Income Eligible Beneficiaries Were **More Likely to be Black, Latino, or Asian**

Reported Race or Ethnicity of Age 65+ California Medicare Beneficiaries, by Income Bracket




Compared to Those with Higher Incomes, Near Medi-Cal Income Eligible Beneficiaries Were **More Likely to Have Limited English Proficiency**

Percent of Age 65+ California Medicare Beneficiaries with Limited English Proficiency, by Income Bracket




Compared to Those with Higher Incomes, Near Medi-Cal Income Eligible Beneficiaries Were **More Likely to Report Disabilities**

Compared to Those with Higher Incomes, Near Medi-Cal Income Eligible Beneficiaries Were **Less Likely to Live with a Spouse**


Percent of Age 65+ California Medicare Beneficiaries with Each Marital Status, by Income Bracket


Compared to Those with Higher Incomes, Near Medi-Cal Income Eligible Beneficiaries Were **More Likely to Live with No Family Members**

Compared to Those with Higher Incomes, Near Medi-Cal Income Eligible Beneficiaries Were **More Likely to Live Alone**

Conclusion

Near Medi-Cal Income Eligible beneficiaries:

- **Had a typical income** (\$22K in 2023 dollars) **closer to Medi-Cal Income Eligible beneficiaries** (\$14K) than to beneficiaries with higher incomes (\$57K).
- **More often were female** (59%) than beneficiaries with higher incomes (51%).
- **More often were age 75 or older** (48%) than beneficiaries with higher incomes (38%).
- **Had a higher representation of Black, Latino, and Asian identities** (45%) than the beneficiary population with higher incomes (28%).
- **More often had limited English proficiency** (15%) than beneficiaries with higher incomes (4%).
- **More often had one or more disability** (41%) than beneficiaries with higher incomes (27%).
 - 20% of Near Medi-Cal Income Eligible beneficiaries had difficulty with tasks outside the home, while 11% had self-care difficulty and 11% had cognitive limitations.
 - All six studied types of disability were more common for Near Medi-Cal Income Eligible beneficiaries than those with higher incomes.
- **Less often lived with a spouse** (43%) than those with higher incomes (65%).
- **More often lived alone** (30%) than those with higher incomes (22%).
