

Due to the design or model of service provision in the setting, individuals have limited, if any, opportunities for interaction in and with the broader community, including individuals not receiving Medicaid-funded HCBS

Summary of Evidence	The provider had imposed restrictions that limited an individual's access to the community including the requirement to sign in and out, locked parking lot, locked doors to which individuals do not have keys or another way to enter their home without staff intervention for all individuals. Individuals living in designated memory care units were not permitted to leave their assigned unit or go into the community without family or staff support.
Summary of Remediation	Palmcrest Grand Residence addressed the blanket restrictions in place in their RWP.
Strategy	Palmcrest Grand Residence developed a policy that clearly identified individuals' rights to be involved in their community and clarified that restrictions would be imposed only when the person-centered team assessed a specific need. Any restrictions will be discussed at least annually and when warranted, restrictions will be lessened. Individuals will have a code to their home so that they no longer must wait for staff to let them into their home. Individuals who have a car have the code to the locked parking lot. Although they will continue to use a sign in sheet it is only used when medications are needed while the individual is away.  In response to the restrictions imposed for individuals who are living in the memory care unit, Palmcrest Grand Residence will assess the risk the individual has for wandering and putting themselves in unsafe situations. Based on the results of that assessment, any restrictions will be discussed at least annually and when warranted, restrictions will be lessened. They develop a policy that affirms individuals' rights to have freedom of movement at their home.
