

SUBJECT: Enhancement to the Income Eligibility Verification System

The purpose of this Medi-Cal Eligibility Division Information Letter is to highlight the new non-wage income data that is now available in the Applicant Income Eligibility Verification System (IEVS-Applicant). The system upgrades were installed using a phased approach, with all modifications outlined in Medi-Cal Eligibility Data System (MEDS) Change Cycle Letters.

Background:

Under federal mandate, the Department of Health Care Services (DHCS) established IEVS-Applicant to assist in providing information required for Medicaid eligibility determinations. IEVS-Applicant is an important program integrity component of the Medi-Cal program by providing valuable income and employment data that counties use in Medi-Cal eligibility determinations.

Using IEVS-Applicant to verify an individual's circumstances ensures accurate eligibility determinations and can minimize the possibility of improper payments for Medi-Cal beneficiaries. IEVS-Applicant Data Enhancements

IEVS-Applicant contains information from multiple sources, including the Franchise Tax Board (FTB). Prior to these enhancements, the FTB data consisted of only two non-wage income types: Interest Income, and Dividends and Distribution Income.

DHCS is now receiving FTB non-wage income data from 13 earning types, and this data is now accessible in IEVS-Applicant. The list of earning types is as follows:

The IEVS-Applicant enhancements increase overall detection capability that enhance program integrity activities. DHCS modified the IEVS-Applicant Inquiry Screens and IEVS-Applicant reports to include expanded fields to display larger dollar amounts, as well as the addition of a field to display the earning type. DHCS anticipates the inclusion of new earning types in IEVS-Applicant will assist eligibility workers in detecting and preventing affluent and other high net-worth individuals from participating in Medi-Cal, thereby improving Medi-Cal payment accuracy.
