SUBJECT: NON-MAGI MC 210 PS (5/07) PROPERTY SUPPLEMENT FORM (Reference: ALL County Welfare Directors Letter (ACWDL) 14-35, and 20-21)

The purpose of this letter is to provide information to counties on the out-of-date instructions on the MC 210 PS (5/07) "Property Supplement" (MC 210 PS (5/07)) form currently sent to Non-Modified Adjusted Gross Income (Non-MAGI) beneficiaries in their annual renewal packets.

## Concern with the MC 210 PS form language:

Counties have informed the Department of Health Care Services (DHCS) that the instructions are confusing when completing the renewal for a child in the Department of Developmental Services (DDS) waiver program and question the following instructions on the MC 210 PS (5/07) form:

"STOP: If you are applying for no-cost Medi-Cal only for children under age 19 and/or pregnant women applying only for pregnancy-related services, you do not need to complete this form. You may be contacted later if necessary."

## Response to the concern:

DHCS understands there may be confusion due to the outdated language in the MC 210 PS (5/07) form. Until DHCS implements a new form, as described below, counties should reassure individuals who have received the MC 210 PS (5/07) form that:

 The instruction on the form does not apply to beneficiaries completing a Medi-Cal redetermination for the DDS waiver program and to please proceed with completing the MC 210 PS (5/07) form for the Non-MAGI evaluation. - Counties may offer to send the beneficiary the MC 604 IPS income and property supplement form in place of the MC 210 PS (5/07) form for Non-MAGI Medi-Cal, if the beneficiary prefers a different form.
- A new prepopulated Non-MAGI MC 210 RV (10/20) renewal form will be available at the end of the year. This new prepopulated Non-MAGI form will include income, property, and additional sections required for annual redetermination and beneficiaries will no longer receive the current MC 210 RV (5/11) and MC 210PS (05/07) forms.

**Note:** Once the prepopulated Non-MAGI MC 210 RV (10/20) renewal form is implemented in December 2021, the current MC 210 RV (5/11) and MC 210 PS (5/07) forms should no longer be used and will be "obsolete". Any remaining copies of the MC 210 RV (5/11) and MC 210 PS (5/07) form should be removed from county inventory.
