SUBJECT: UPDATED INCOME AND DEDUCTIONS CHART

The purpose of this letter is to inform counties of the updates to the "Modified Adjusted Gross Income (MAGI) Income and Deductions Types" chart, located in the <u>County</u> <u>Operations Support</u> portion of the Department of Health Care Services (DHCS) website.

DHCS updated the following income types for MAGI Medi-Cal and Advanced Premium Tax Credit (APTC)/Cost Sharing Reduction (CCR):

 - Emergency Rental Assistance
 - Mixed Earner Unemployment Compensation
 - Paycheck Protection Program Second Draw Loans

- Acquisition or Abandonment of Secured Property
- Real Estate Transaction Proceeds
