LANGUAGES MC 216 (10/20), MC 210 RV (10/20) AND MC 217 (10/20)
ANNUAL RENEWAL PREPOPULATED FORMS Reference: MEDIL [I21-14](#),
MEDIL [I21-16](#), **and ACWDL [I20-21](#)**)

The purpose of this Medi-Cal Eligibility Division Information Letter (MEDIL) is to provide counties with an updated timeline on the Statewide Automated System (SAWS) programming dates for the remaining threshold languages versions of the MC 216 (MAGI), MC 210 RV (Non-MAGI), and MC 217 (MAGI and Non-MAGI mixed household).

Summary of Changes

Corrections to MEDIL I 22-07 are noted as follows:

- Strike-through for deleted language
- Underline and bolding for new language

In addition to English and Spanish, SAWS currently supports the following threshold languages:

The threshold languages not supported by SAWS at this time and SAWS will release in the future include:

SAWS Programming Timeline

CalSAWS

The following are CalSAWS programming release dates for the annual renewal prepopulated forms in the supported threshold languages:

- MC 216 (MAGI) – ~~March~~ **May** 2022
- MC 210 RV (Non-MAGI) – May 2022
- MC 217 (MAGI and Non-MAGI mixed household) – July 2022

CalWIN

The programming ~~release dates~~ of all annual renewal prepopulated forms in the supported threshold languages for CalWIN is **complete as of March September** 2022.

Department of Health Care Services (DHCS) will issue future MEDILs to advise counties:

- The release of the fillable and American with Disabilities Act compliant PDF versions of the threshold language prepopulated annual renewal forms become available on the DHCS website.
- When the SAWS complete programming and release the six remaining threshold language prepopulated annual renewal forms.

Reminders:

- Counties/SAWS must provide the [GEN 1365](#) Language Access Services for Limited-English Proficient and Non-English Proficient Individuals with all annual renewal forms.
- Counties are to provide forms in alternate formats upon request.
- **The MC 262 and MC 604 IPS are not obsolete and counties will continue to use these forms during intake, change of circumstance redeterminations, or as a supplemental form if the beneficiary requests a Non-MAGI evaluation, where appropriate.**
