SUBJECT: Procedure for Updating County Contact Information

This Medi-Cal Eligibility Division Information Letter (MEDIL) provides guidance to counties on the process for updating county address and phone number information. It is essential that counties maintain up-to-date contact details to ensure accurate and preferred information is reflected on the DHCS County Offices webpage (<u>https://www.dhcs.ca.gov/services/medi-cal/Pages/CountyOffices.aspx</u>) and CalHEERS Portal (<u>https://www.coveredca.com</u>). This helps members access the correct county office information for Medi-Cal and health coverage services.

Counties are required to keep their contact information, including county addresses and phone numbers, up to date to ensure proper communication and service delivery. The following steps outline the process for updating these records:

1. Prepare Update Information:

Counties must verify that their updated and preferred address and phone number are complete and accurate, ensuring both the physical and mailing addresses are included if they differ.

2. Submission Process:

County offices should submit updates via the attached form. Please ensure all fields are completed before submission. Submit change request to <u>MCEDSystemsPOC@dhcs.ca.gov</u>.

3. Submission Deadline:

Counties are required to submit changes to addresses and phone numbers within five (5) business days of the change. Timely updates are critical to ensure that the DHCS County Offices website, Covered California website and member noticing reflect the most current information.

4. **Processing Time:**

DHCS will process updates within 7-10 business days after submission. Counties will receive confirmation once the changes are successfully updated.

5. Ongoing Review:

Counties should periodically review their contact information on the DHCS County Offices website (<u>https://www.dhcs.ca.gov/services/medi-</u> <u>cal/Pages/CountyOffices.aspx</u>) to ensure accuracy and make updates as necessary. Covered California will also use this information to direct members appropriately.

6. Failure to Comply:

Failure to update contact information promptly may result in outdated information being displayed on public websites and notices, which could lead to communication issues and service delays for Medi-Cal applicants and members.

Effective Date:

This policy is effective immediately upon release of this MEDIL and should be followed for all future updates to county contact information.
