ISSUANCE OF NEW BENEFICIARY IDENTIFICATION CARDS (BICS)

Effective February 1, 2002, the Department of Health Services' (Department) Medical Review Branch is placing requirements on billings for a number of Medi-Cal Benefits Identification Cards (BICs ID) in an ongoing effort to determine if BICs have been stolen or misused. Initially, new BICs will be issued with a new BIC ID number and issue date to approximately 2,000 recipients. This process will be repeated on a periodic basis as misuse of the BIC for other recipients are discovered. The new eligibility message, "Current BIC ID number and issue date required for payment," will be placed on approximately 2,000 recipients' eligibility files, which will be provided upon eligibility verification requests.

The Department is sending the enclosed letter to the beneficiaries informing them of the issuance of their new cards in January 2002. This letter tells them the old card will be invalid after receiving the new one. The letter also assures them that their health care benefits will not change. It further reminds them of their responsibility to protect their card from abusive or fraudulent use.

Providers billing for services with the beneficiaries' old cards will receive a new error message from Electronic Data Systems. This message will be error code "600" with an explanation of "Current BIC number and issue date required for claims payment".

You are getting a new card because some one else may be using your card for services you did not get. Keep your new Medi-Cal card safe. Do not give your card or number to anyone unless it is for your care. Selling your card is a crime.
