SUBJECT: QUALIFYING INDIVIDUAL PROGRAM SUNSET DATE AND TEMPORARY EXTENSION OF THE QI-1 PROGRAM

Ref.: All County Welfare Directors Letter Nos.: 98-08, 98-15, 98-47, 98-60,99-14, 99-61, and 99-43)

This letter is to notify the counties of the temporary extension of the QI-1 program and the discontinuance of the QI-2 program.

The QI-1 and 2 programs are Medicare Savings programs that pay all or reimburse a portion of the Medicare Part B premium. According to federal law, both programs are scheduled to sunset effective December 31, 2002. The Department of Health Services (Department) was first instructed by the Centers for Medicare and Medicaid Services to discontinue QI coverage by the effective sunset date.

The Department has since been informed of a Congressional Continuing Resolution (CR) to continue the QI-1 program and its federal funding through March 13, 2003. This is an interim solution until Congress can either extend or remove the sunset date from federal law. The QI-2 program will not continue. If Congress still has not taken action to continue the QI-1 coverage, another CR may be passed.

The Department will discontinue the QI-2 coverage on the Medi-Cal Eligibility Data System, send the QI-2s a notice of discontinuance and instruct them to contact their county welfare department if they wish to apply for Medi-Cal coverage.

The Department will also send listings of the discontinued QI-2 individuals to the counties, so that the county can close their case files. The county is not responsible for redetermining these individuals for Medi-Cal coverage unless they have been contacted by the former recipient.
