SUBJECT: DISTRIBUTION OF THE HEALTH INSURANCE PORTABILITY AND
ACCOUNTABILITY ACT NOTICE OF PRIVACY PRACTICES TO MEDI-CAL
ELIGIBLES

As described in All County Letter No. 03-18, dated April 21, 2003, the Department of Health Services (DHS) sent out a Notice of Privacy Practices (NPP) to all Medi-Cal recipient households, as mandated by the Health Insurance Portability and Accountability Act (HIPAA) Final Privacy Rule.

Information Technology Services Division (ITSD) is working on a computer program that will be used to identify new eligibles on the Medi-Cal Eligibility Data System (MEDS) database in order for DHS to mail a NPP to the new eligibles. The estimated date for this process to be in place is mid-October, 2003. However, it may take longer than that before the programming is completed and a mailing process established.

DHS is concerned that new Medi-Cal enrollees are not receiving this important information, which is mandated by law. Until you are notified by DHS that the automatic noticing process through MEDS is in place, DHS is requesting that the NPP distribution be incorporated into the manual Medi-Cal eligibility process so that new beneficiaries can receive a copy of the NPP.

DHS is asking counties to provide the Office of HIPAA Compliance with a contact person, an estimate of the number of English and Spanish NPPs that are needed based upon the monthly new enrollees, and a mailing address where a month's supply of these notices may be sent. Please e-mail this information to sfanelli@dhs.ca.gov by September 5, 2003. Counties will receive the requested number of the Spanish and English NPPs to provide to beneficiaries.
