The enclosed chart provides you with the poverty levels to be effective April 1, 2005, through March 31, 2006, for the Qualified Medicare Beneficiary (QMB), Specified Low-Income Medicare Beneficiary (SLMB), and Qualified Individual 1 (QI-1) programs. These ceilings are derived from the federal poverty levels published in the Federal Register on February 18, 2005, and are used when determining income eligibility for the QMB, SLMB, and QI-1 programs.
