The purpose of this All County Welfare Directors Letter is to provide counties with the Pickle Tickler Type 52 NOA address list and to request updates. Pursuant to the Lynch v. Rank lawsuit, the Pickle Tickler Type 52 NOA is a letter sent to the home address of individuals who currently receive Title II Retirement, Survivor's and Disability Insurance payments and were determined not eligible for the Pickle program immediately following discontinuance from Supplemental Security Income/State Supplemental Payment. The county contact information is listed on the Pickle Tickler Type 52 NOA and this information aids potential Pickle eligible individuals in requesting county assistance to apply for the Pickle program.
