SUBJECT: PICKLE TICKLER REPORT SECURE E-MAIL ADDRESS DATABASE

The purpose of this All County Welfare Directors' Letter is to provide counties with the current secure e-mail address database, which Pickle Tickler Reports are scheduled to be sent to (enclosures), and to request updates to the database.

Pursuant to the *Lynch v. Rank* lawsuit, Pickle Tickler Reports contain the names and addresses of individuals who currently receive Title II Retirement, Survivor's, and Disability Insurance payments and were determined not eligible for the Pickle Program immediately following discontinuance from Supplemental Security Income/State Supplementary Payments.

In December of each year, the Department of Health Care Services (DHCS) securely transmits Pickle Tickler Reports to each county in order to support annual redeterminations of these individuals. DHCS intends to transmit Pickle Tickler Reports the last week of December 2012. To avoid errors in updating the county secure e-mail address database, please provide updates in writing no later than November 16, 2012.
