MODE OF TAPE SHIPMENT AND CHARGES

Since DHS absorbs all mailing costs, counties are required to use Greyhound-Express, if available, as the charges are very reasonable and the service is advantageous to both the State and the county. - (1) GREYHOUND COVERS MOST OF CALIFORNIA. ANY TAPE DELIVERED TO GREYHOUND ANYWHERE IN THE STATE WILL BE IN SACRAMENTO IN LESS THAN 24-HOURS. MEDS CONTROLS COURIER WILL PICK-UP AT SACRAMENTO BUS DEPOT. ONE MAIN ADVANTAGE OF GREYHOUND SERVICE IS THAT THEIR DEPOTS ARE OPEN 24-HOURS, 7-DAYS PER WEEK IN MOST CITIES ALLOWING MEDS CONTROLS THE OPTION OF SHIPPING PACKAGES ON WEEKENDS AND HOLIDAYS FOR DELIVERY WITHIN CALIFORNIA BY THE NEXT BUSINESS DAY.

- (3) AIRBORNE WILL PICK-UP AT COUNTY OFFICE BETWEEN 9:00AM AND 9:00PM AND DELIVER TO SACRAMENTO AS NOTED IN (3), (4), OR (5) BELOW.
- (4) FEDERAL EXPRESS WILL PICK-UP AT COUNTY OFFICE BETWEEN 9:00AM AND 4:00PM AND DELIVER TO SACRAMENTO AS NOTED IN (3), (4), OR (5) BELOW.
- (5) DELIVERED BY NOON OF THE NEXT BUSINESS DAY.
- (6) DELIVERED BY 5:00PM OF THE NEXT BUSINESS DAY.
- (7) DELIVERED WITHIN 48-HOURS OF PICK-UP BY CONTRACTED COURIER.
- (8) POSSIBLE ALTERNATE SHIPPING POINTS.
- (9) DEPARTURE AIRPORTS AND TIMES FOR ARRIVAL IN SACRAMENTO TO MEET THE REQUIRED MEDS CUT-OFF TIMES.

- (GH) COUNTIES THAT WE HAVE RECORDS ON AS REGULAR GREYHOUND SHIPPERS, ALTHOUGH IMPERIAL SOMETIMES USES U.S. MAIL AND ORANGE USES AIR-CAL FOR ABOUT HALF THEIR SHIPMENTS. WE HAVE NOT DETERMINED IF ANY COUNTIES USE GREYHOUND EXPRESS.

WE PREPARED THIS SHIPPING STUDY USING MODES OF TRANSPORTATION THAT CAN DELIVER COMPUTER TAPES IN LESS THAN 24-HOURS AND THAT WE HAVE ACCESS TO AT TIMES OTHER THAN 'NORMAL' WORKING HOURS. FOR THOSE REASONS U.S. MAIL AND REGULAR UPS SERVICES WERE NOT CONSIDERED (UPS DOES HAVE AN 'OVERNIGHT' SERVICE, AVAILABLE 'NORMAL' WORKING HOURS FOR A COST OF APPROXIMATELY \$15.00). U.S. MAIL AND REGULAR UPS ARRIVES AT MEDS CONTROLS 3-5 DAYS FROM THE DATE A COUNTY MAILED.
