LYNCH V. RANK TRAINING SCHEDULE

During the months of April and May, Eligibility Branch staff and the State and County Medi-Cal Policy Task Force members will be conducting mandatory county training on the revised procedures for determining Medi-Cal eligibility under the Pickle Amendment.

Since the original Pickle training was conducted in November 1983, extensive changes have been made which necessitate this training. Also, a settlement has been reached on the retroactive reimbursement portion of this lawsuit and part of the training will focus on that process.

Due to the complexity of the subject matter the number of participants will be limited to a maximum of four per county. It is recommended, if possible, that your designated county contact person (ACWD Letter 85-25) attend this training.
