NEW MEDS LIAISON ASSIGNMENTS

This is to inform you of the Medi-Cal Eligibility Branch (MEB), Systems Unit, Medi-Cal Eligibility Data System (MEDS) Liaison staff new county assignments and to give you a brief reminder of the general duties of the Systems Unit. The attached list shows the names and telephone numbers of each staff person and the counties for which each is responsible. Please note the liaison for your county and contact him/her for any MEDS problems/ questions.

The Systems Unit is generally responsible for the MEDS and other operational functions. With the exception of those matters that would require you to contact the Data Systems Branch directly, the Systems Unit should be your first point of contact for any eligibility system issues. Please note, to avoid confusion and the duplication of work, the county MEDS Coordinator/Liaison or supervisor, should be the person contacting the State MEDS Liaisons.

The attached organizational chart identifies the functions performed by the Systems Unit staff in addition to their duties as MEDS Liaisons. While this list is not all inclusive it indicates the types of functions performed and should help you in determining which staff to contact.
