SUBJECT: FY 86/87 MAINTENANCE NEED AND INCOME IN KIND LEVELS

This letter provides you with the revised medically needy maintenance need and income in kind levels which are adjusted to reflect the cost of living adjustment (COLA) proposed in the Governor's 1986/87 budget. Although this COLA is subject to legislative approval and Governor action, again this year there will not be a trailer bill and it is anticipated that these new levels will be effective July 1, 1986 (see attached).

Once the Governor's Budget is signed in June, you will be notified immediately via a SYSM message if there is any change in these proposed levels and/or confirming the attached revised levels and authorizing implementation July 1, 1986. Additionally, the levels will be distributed to all holders of the Medi-Cal Eligibility Manual at that time.
