Subject: Verification of Licensed Primary Care Clinics (PCC)

This is to advise all County Welfare Departments (CWD) that the Medi-Cal Eligibility Branch has determined that the creation and distribution of a listing of Primary Care Clinics (PCC), as mentioned in All County Welfare Directors Letter No. 87-10, is not feasible at this time.

A better recommendation is for all CWD's, who wish to verify the licensure of PCC's, to contact the local Licensing and Certification District Office of the Department of Health Services located in their area. This will ensure that the counties can obtain the most current updated information as opposed to a periodic listing which becomes frequently outdated. We have attached a list of all District Offices in the state.
