FY 1987/88 MAINTENANCE NEED AND INCOME IN KIND LEVELS

This letter provides you with information on maintenance need and income in kind levels for FY 1987/88 for the Medi-Cal program.

The Governor's 1987/88 budget contains a cost of living adjustment (COLA) for the Aid to Families with Dependent Children (AFDC) cash assistance program. According to current state statute, Medi-Cal maintenance need levels are tied to the AFDC cash payment level. However, the Governor's budget currently does not contain a COLA for the Medi-Cal program. Therefore, until such time as the 1987/88 budget is passed by the Legislature and signed by the Governor, we are unable to provide you with authoritative information on future maintenance need and income in kind levels.

In the event the proposed AFDC COLA is approved and the current state statute governing the Medi-Cal income levels for maintenance remains operative, the attached maintenance need and income in kind levels would become effective July 1, 1987. Once the Governor's budget is signed in June, we will immediately inform you via a SYSM message whether there will be a Medi-Cal program COLA, and, if so, confirm or revise the attached maintenance need and income in kind levels as appropriate.
