SUBJECT: SYSTEMS ERRORS

This letter is to provide you with a reminder that Quality Control (QC) errors will be cited on those cases in which changes were made by county personnel into the County system but not accepted by MEDS. Based upon QC review, it has become apparent that in some instances MEDS error alerts are being ignored. The MEDS system is being allowed to generate incorrect Medi-Cal cards for months, until the error is caught during the quarterly reconciliation of the State and County System.

As you know, when you enter a transaction into your computer system, it must pass through a set of edits or you will receive an error alert. The error must be corrected before the computer will accept and complete the transaction. When this information is then transferred to the State computer system (MEDS), the information must once again pass through a set of edits before it will be accepted. If the input is found to be unacceptable in some way, an error alert is immediately generated.

To avoid error citations counties should review error messages received from the State. These messages inform the counties that a transaction was not accepted. If termination was to take place, immediate correction is necessary. Counties should not wait for the quarterly reconciliation process.

If an incorrect Medi-Cal card is issued in the Quality Control review month, counties will be cited unless they can provide evidence that MEDS was "down" at the time of the attempted transaction or that a change was accepted by MEDS in time for the review month card to be printed correctly (or to be discontinued). The evidence must clearly demonstrate that the error was the fault of the State system, otherwise an error will be cited to the County.

A list of counties and their respective MEDS transaction cut-off dates (renewal dates) is attached (see Bulletin No. 91). Quality Control analysts are instructed to use these cut-off dates to assist in determining errors.

ONLINE EXTENDED HOUR PROVISIONS

- o The network and MEDS database will be available extended hours ONLY from 1700 hours until Midnight, Monday through Friday, except as indicated below.
- o At 1700 there will be a 'cutover'. This will entail initiation of the daily processing or update. All online transactions completed by that time will be included in the current day's processing. All transactions completed after that time will be processed in the following day's update process. PLEASE NOTE THE TIME OF 1700 HOURS.
- o On the evening of 'RENEWAL', the network will be closed at 1700 hours.
- o The HWDC Help Desk will be available during these extended hours.
