SUBJECT: INFORMING ALL MEDI-CAL APPLICANTS ABOUT THE SPECIAL SUPPLEMENTAL FOOD PROGRAM FOR WOMEN, INFANTS AND CHILDREN (WIC)

The purpose of this letter is to inform you of the requirements of Section 6406 of the Omnibus Budget Reconciliation Act of 1989. This section requires the Department of Health Services (DHS) to inform Medi-Cal applicants about the Special Supplemental Food Program for WIC. Specifically, it requires DHS to: a) notify in a timely manner all individuals in the State who are determined to be eligible for medical assistance and who are pregnant, breastfeeding or postpartum women and children under the age of five, of the availability of benefits furnished by WIC; b) refer any such individual to the State agency responsible for administering such program; and c) verbally explain WIC benefits to all women and children found to be eligible for WIC who are unable to read.

In meeting these requirements, we are instructing counties to give a copy of the WIC handout (copy enclosed) to all new Medi-Cal applicants at the time of their face-to-face interview and verbally explain WIC benefits to those individuals who are unable to read. We feel this meets the intent of the WIC requirement. Please start this activity no later than March 1, 1991. For ease of administration, we are requesting that it be given to all applicants.

In addition, DHS developed a WIC stuffer (copy enclosed) which will be mailed to all existing Medi-Cal eligible individuals on an annual basis. This year's stuffer will be mailed out with the November 1990 Medi-Cal cards. Subsequent years' stuffers will be mailed out each November.

Counties will be able to order a supply of the WIC handout from the DHS warehouse beginning November 15, 1990. (Please feel free to distribute the WIC handout prior to the March 1, 1991 effective date if you so desire).
