SUBJECT: ACCESS FOR INFANTS AND MOTHERS PROGRAM (AIM)

The purpose of this letter is to inform you of a new health insurance program established in California for pregnant women and infants called the Access for Infants and Mothers Program (AIM). This program, which is administered by The California Major Risk Medical Insurance Program, is expected to begin offering coverage in January 1992. The objective of the AIM Program is to increase access to perinatal care and health care by providing affordable coverage to the uninsured population of low-income pregnant women and infants who do not qualify for Medi-Cal because of excess assets, or who have income which would require them to pay a share of cost.

In order to be eligible for the AIM Program, subscribers must: 1) be a California resident for at least six continuous months prior to application; 2) have family income at or below 250 percent of the federal poverty level at time of application (no asset test); 3) not be a Medi-Cal/Medicare beneficiary at the time of application; and 4) not be covered by comparable private insurance benefits.

Enclosed for your information is a fact sheet distributed by the Major Risk Medical Insurance Program which highlights the eligibility criteria, benefits, costs, etc. of the AIM Program. Counties can obtain more information regarding the AIM program by contacting the AIM program directly at the address and telephone number listed on the enclosed fact sheet.

SUMMARY OF PERINATAL INSURANCE INITIATIVE ACCESS FOR INFANTS AND MOTHERS PROGRAM (AIM)

Highlights:	 * Increased access to maternity, delivery, and infant care services for low income women. * Better birth outcomes due to increased access to care. * Reliance on the existing financing and health care delivery systems. * Affordable premiums for subscribers. * Streamlined, easy to use application and eligibility process.
Eligibility Criteria:	 California resident for atleast six continuous months prior to application. Family income at or below 250% of the federal poverty level at time of application with no asset test. Not a Medi-Cal of Medicare benficiary at the time of application. Not covered by comparable private insurance benefits.
Benefit Package:	Subscribers will be covered for all medically necessary medical services during preganacy, 60 days postpartum, and for 2 years of infant care following the birth of the child.
What will it Cost?	The subscriber contribution will be capped at 2% of gross family income. For a family of two with an annual gross family income of 250% of the federal poverty level (\$21,280), the subscriber contribution would be \$425.60. The initial subscriber contribution will be no more than \$50, however subscribers must agree to the payment of the complete subscribe contribution.
How will care be Provided?	Subscribers will choose from a variety of health provider networks which will contract with the state to provide covered benefits.
Will the number of subscribers be limited?	The number of subscribers will be limited based on the funds appropriate for this purpose. AB 99 of 1991 appropriates \$44m in FY 1991-92, and \$57m in FY 1992-93 and FY 1993-94 in state Cigarette & Tobacco tax revenues for implementation of the program.
When will coverage begin?	The program expects to begin offering coverage in January of 1992.
