SUBJECT: OMNIBUS BUDGET RECONCILIATION ACT OF 1990 OUTSTATIONING AND PERINATAL OUTSTATIONING

The purpose of this letter is to provide updated information and instructions regarding implementation of the provisions of the Omnibus Budget Reconciliation Act of 1990 (OBRA 1990) relating to outstationing of eligibility workers. This letter also provides information relative to the submission of your petitions for continued funding of Perinatal outstationing.

## General Information Regarding OBRA-90 Outstationing

The OBRA-90 outstationing legislation provides for the receipt of and initial processing of applications from pregnant women and children born after September 30, 1983, who have not yet attained 19 years of age, at locations other than welfare offices. The legislation allows for initial processing of applications by eligibility workers, provider employees, volunteers, or provider contractors.

Initial processing means taking applications, assisting applicants in completing the application, providing information and referral, obtaining required documentation needed to complete processing of the application, assuring completeness of the information contained, and conducting any interviews. When county welfare department staff are assigned to perform these tasks, the legislation allows complete the processing of eligibility (i.e., examining and verifying information provided on the Statement of Facts (MC-210), making the eligibility determination, conducting follow-up interviews when additional information is required) at the outstation location. We anticipate at this time that the entire eligibility process will be conducted at OBRA-90 locations by county welfare department staff.

The legislation mandates that each disproportionate share hospital and each federally qualified health center (FQHC) participating in the State's Medicaid program must have a qualified person to take applications and must assist applicants with the application process. Other significant aspects of this legislation are:

 Staff must be available at the outstation locations during the hours welfare offices are normally open to accept applications and assist applicants with the application process, except:

- At low use locations, a welfare department employee may be assigned to several outstation locations on a rotating basis, provided that when the eligibility workers are not available, a notice is prominently displayed at the location advising potential applicants when such eligibility workers are available. The notice must provide a telephone number which the applicant can call for assistance with initial processing of an application. Applications must be available at the site.
- An applicant may not be required to visit any site other than the outstation site. The object here is "one place shopping" in terms of the application process.
- The Health Care Financing Administration (HCFA) has stated that they expect California to assure outstationing provisions are met for all disproportionate share hospitals and FQHCs unless it can be demonstrated on a case-by-case basis, that it is not administratively reasonable given the small size of the pregnant women population in a given area.

# Federally Qualified Health Centers (FQHCs)(Including Indian Health Centers and "Look Alike" Clinics)

#### FOHC Background

The Omnibus Budget Reconciliation Act of 1989 (OBRA-89) established community and migrant health Centers (C/MHCs) and federally funded health care for the homeless programs (i.e. U.S. Public Health Service Section 329, 330 and 340 grantees) as FQHCs under the Medicaid program. When creating FQHCs, Congress recognized that certain health centers existed that could meet the requirements for C/MHCs, though they did not receive federal funds and thus could not receive automatic FQHC designation. These centers are referred to as "look alike" health centers and are permitted under the law to apply for FQHC status.

The Omnibus Budget Reconciliation Act of 1990 (OBRA-90) refined the FQHC definition under Medicaid. Under the clarifying provisions, outpatient health programs operated by Indian tribes or tribal organizations under the Indian Self-Determination Act could qualify as FQHCs.

All organizations wishing to be FQHC providers must apply for this status. For C/MHCs and federally funded health care for the homeless programs, designation is automatic upon request. For other entities the application for FQHC status is similar to that of applying for C/MHC or health care for the homeless program funding, although the data requirements are less extensive.

Enclosed is a list of FQHCs. Included on the list are Indian Health Centers and "Look Alike" Clinics. The list consists of organizations which have attained FQHC status as of December 1991. The list does NOT include facilities which may be eligible to attain this status but have not applied. If inquiries are received by counties from clinics not on the enclosed list concerning the outstationing of eligibility workers under OBRA-90, the agencies should be told they must first apply for FQHC status. To apply for FQHC status, the agency should contact:

Some of the FQHCs have clinics which are located in more than one county. For purposes of outstationing eligibility workers, the FQHCs may have to negotiate with more than one county. On the enclosed list we have cross-referenced clinics with locations in more than one county. The county where the clinic is physically located is the county responsible for outstationing the eligibility worker.

Upon receipt of this list, counties must initiate contact with the clinics in their areas. A contact person and phone number for each clinic is included. Counties must determine if the clinic is providing services to the OBRA-90 targeted population, and if so, develop a plan to outstation workers at the clinic.

If you currently have eligibility workers stationed at FQHCs or Disproportionate Share Hospitals through the perinatal outstationing program, you will need to assure, no later than July 1, 1992 and to the extent possible, that applications for children born after September 1, 1983 are accepted. Although some of these children are currently having their eligibility determined when they are included in the MFBU of a pregnant woman who is applying, OBRA-90 mandates children born after September 18, 1983 who are receiving services at mandated sites must also have their eligibility determined.

For those counties who are prepared to implement outstationing at these sites effective April 1, 1992, incremental funding is available. In order to properly allocate funding, however, it will be necessary for you to develop a separate petition for the period April 1, 1992 - June 30, 1992 identifying the proposed levels of staffing and numbers of projected applications at each site.

When preparing petitions for OBRA-90 sites please remember that OBRA-90 mandates outstationing workers only during the hours the welfare department is normally open. If you provide workers at OBRA-90 sites during periods other than normal welfare department hours, you should not request funding through OBRA 90 for the expanded hours.

# Disproportionate Share Hospitals

A list of disproportionate share hospitals was previously provided to counties. In an effort to determine which disproportionate share hospitals provided services to the targeted OBRA-90 population, we sent a questionnaire in November 1991 to the Administrators of Disproportionate Share Hospitals. The information obtained through the survey was also intended to provide information to the counties which could be used as a starting point in developing petitions for outstationing at facilities which do provide services to the targeted population. Results of the survey are being mailed separately to the Medi-Cal Program Managers of counties who have Disproportionate Share Hospitals which responded to the survey.

Counties will need to contact each disproportionate share hospital which provides services to the OBRA-90 targeted population and determine the feasibility of placing an outstationed worker at the hospital.

## Continued Funding for Perinatal Outstationing

In addition to preparing petitions for OBRA 90 outstationing, counties who currently have eligibility workers outstationed at perinatal clinics should submit their petitions for perinatal outstationing for the fiscal year beginning July 1, 1992. The dollar amount in the Governor's budget for perinatal outstationing is essentially the same as for the last fiscal year. Therefore, we do not anticipate any significant changes in the number of sites or staffing levels for the next fiscal year. We are asking for your cooperation, however, in assessing your current program to determine if there are locations where volume is not as great as expected, or where, for other reasons, the arrangement has been determined not to be cost beneficial. The petition format for continued perinatal outstationing will be the same as for the current fiscal year. This format was provided to you in All County Welfare Directors Letter 91-25, and a copy is also enclosed with this letter.

NOTE: If you have perinatal outstationed workers at sites which are FQHCs or disproportionate share hospitals, funding for these locations should be requested under the OBRA-90 petitions.

## Forms to Be Used for Outstationing Eligibility Workers

Enclosed with this letter are forms to be used in developing your petition for outstationing workers. Following is a brief description of the forms and instructions for their use:

## 1. <u>Petition Summary</u>

Each county with OBRA-90 mandated sites should complete this form to provide a summary of the total number of sites, eligibility workers, and projected number of applications to be processed.

# 2. <u>Petition Enclosure A - Disproportionate Share Hospitals and Federally</u> <u>Qualified Health Centers</u>

One of these forms should be completed for each location at which you are proposing to outstation eligibility workers. The form provides information on projected number of applications, EWs necessary to process applications, travel time of EWs and language skills necessary.

#### 3. <u>Petition Enclosure B</u>

If you determine it will not be administratively feasible to outstation a worker at an OBRA-90 location, one of these forms should be completed telling us why you do not anticipate outstationing a worker at this location.

#### 4. <u>Petition for Continuation of Funding for Perinatal Outstationing</u>

This form should be completed by those counties wishing to continue and/or modify their funding for outstationing eligibility workers at perinatal sites. Do not include any perinatal sites which are disproportionate share hospitals or federally qualified health centers (OBRA-90 sites).

# Timeframe for Submission of Petitions

Petitions for OBRA 90 outstationing should be submitted by March 15, 1992. By March 20, 1992, we must provide our fiscal staff with estimates of the number of projected OBRA 90 sites and number of eligibility workers to staff these sites.

Petitions for continued funding of perinatal sites for fiscal year 1992-93 should also be submitted by March 15, 1992. All outstationing petitions should be sent to:

# OBRA-90 Incremental Funding and Reporting Requirements

After the petitions for OBRA-90 funding have been reviewed, counties will be notified of the allocation level for OBRA-90 outstationing. Incremental funding for OBRA-90 will be handled in the same manner as it was for perinatal outstationing. For an overview of the incremental funding process, see All County Letter 91-25.

Once OBRA-90 has been implemented, it will be necessary for counties to complete status reports showing the number of applications processed.

Further information concerning reporting requirements will be provided in All County Letter to be issued prior to July 1, 1992.
