SUBJECT: Pickle Date When SSI Last Received and Title II Amounts On MEDS

The purpose of this letter is to advise the counties that they can now use the Pickle 503 Leads Report message (enclosed) "SSI-LAST-RECEIVED" and date as the official date SSI was last received for a potential Pickle individual. This information can also be verified on the INQO MEDS screen (enclosed) which indicates the "SSI-LAST-RECEIVED" date. Counties will no longer have to query the Social Security Administration (SSA) for this information.

In addition, counties can use the INQB MEDS screen (enclosed) "Bendex Title II Information" which indicates the "CUR-BENEFIT-AMT" (Current Benefit Amount) needed to compute the financial status information for the potential Pickle eligible individual. Accessing this information from the Bendex will preclude the need to query SSA or to see the award letter. These new procedures should serve to shorten the Pickle program's processing time.
