LOCAL EDUCATIONAL AGENCIES (LEA) ENROLLED IN MEDI-CAL BILLING OPTION

Please refer to All County Letter No. 94-24 that described the LEA Medi-Cal Billing Option program. Under this new program LEAs can now be Medi-Cal providers and submit claims for specified LEA bundled services they provide to Medi-Cal eligible children.

Eligibility verification may be a problem for LEAs since students do not bring their Medi-Cal cards to school. In order to assist LEAs, the Department of Health Services has established a procedure to determine eligibility for services provided for fiscal year 1992-93. The retroactive claiming procedures were especially designed for LEAs. Retro billing is a one-time only process. An information package was sent to LEAs describing the retroactive eligibility process. This process does not require any assistance from county welfare departments (CWD).

A number of counties asked for a listing of LEAs which are currently enrolled or have enrollment pending. We have prepared the enclosed listing of the 44 LEAs enrolled and the 23 LEAs with applications pending. The list of LEA Medi-Cal providers is increasing weekly. Upon request, updated information on LEAs enrolled in the Billing Option can be provided by the Department of Health Services, Office of School-Linked Services.

For the prospective billing process, the Department suggests CWD explore ways of verifying eligibility information with local school officials from districts participating in the LEA Medi-Cal Billing Option. LEAs are required to use LEA Medi-Cal reimbursements to expand health and social services for their students.
