WHAT: The Department of Health Services, Medi-Cal Eligibility Branch is pleased to offer three new full-time *limited term* contract positions for current county eligibility supervisors and managers only! These positions are for policy program analysts. These are **not** permanent civil services positions.

This is a unique opportunity for county staff skilled in the Medi-Cal eligibility process to:

- ◆ **G**ain valuable experience at the state level,
- ◆ **R**elocate to Sacramento,
- ◆ **E**xpand your horizons,
- ◆ **A**ssist in the planning and development of statewide health and welfare reform policies, including the Statewide Automated Welfare System Multiple County Consortium Project, and
- ◆ **T**ake firsthand knowledge of the key programs back to your county.

WHEN: All contracts will begin as soon as final and approved. Contracts will have a term of two years.

WHERE: All staff will be located at 714 P Street in Sacramento for the term of the contract unless otherwise agreed. Relocation will be at the successful candidates' own expense. These are contract, not civil service, positions.

QUALIFICATIONS: Candidates must have:

- ◆ Strong analytical skills,
- ◆ A thorough knowledge and understanding of current federal and state Medi-Cal eligibility laws and regulations, and
- ◆ Strong written and verbal communication skills.

County personnel interested in this assignment should already have several years experience with determining Medi-Cal eligibility policy and procedures at the county level. Successful candidates will be able to function effectively in a professional analytical position as demonstrated by prior experience in their county.

Candidates must be able to perform duties with minimal supervision and eventually exercise considerable independent judgement in making decisions and recommendations which have significant legal impact on California's Medi-Cal program as well as affecting county government operations and the health and welfare of the beneficiary population.

- ✓ Assist in the development, analysis, revision and implementation of federal and state Medi-Cal eligibility legislation, regulations, procedures, forms and notices of action.
