Background

Prior to this enhancement, MEDS maintained only one pending address and one current address. MEDS used this pending or current address as a mailing address. This address may also, but not necessarily, have been the residence address. This address had a freeform, 38-character street address line, and may also have had a 38-character freeform "in care of" first address line. City, state, and zip code (five digits) were also populated. This address was checked for completeness, but was not run through any address edit/standardization logic prior to posting to MEDS. An address flag, generated by MEDS, indicated whether this address had passed the completeness edits, a Beneficiary Identification Card (BIC) had been mailed to this address, or a BIC had been returned due to a non-mailable address. Residence address, authorized representative address, and residence county (current or pending) were not maintained on MEDS.

This enhancement will:

- Use the existing address fields as a mailing address;
- Provide new address fields for reporting residence address, separate mailing address, and authorized representative address;
- Edit and process all transaction addresses through address edit/standardization logic (FINALIST) prior to posting to MEDS. FINALIST is a commercial software package that contains post office certified addresses within the State of California;
- Store each MEDS address in a standardized format;
- Provide an address flag for each address, which indicates whether this address passed FINALIST edits, a BIC has been mailed to this address, or a BIC has been returned from this address;
- Allow the address flag for any MEDS address to be entered on county and State Data Exchange transactions;
- Use an address hierarchy to determine which address to use for BIC mailings and Notice of Action (NOA) letters;
- Maintain residence county, for pending, current, and history months; and
- Provide an out-of-state code for residence county when the recipient lives outside of California.

A particular benefit of this enhancement to counties is the maintenance and use of residence county in determining HCP eligibility when a client is not residing in the county that is responsible for their eligibility (for example pending intercounty transfers and foster care placements). If the recipient lives in a county other than the county responsible for their case, the residence county field can be used to override the county of responsibility for HCP purposes. Prior to this enhancement, clients whose responsible county was a County Organized Health Systems (COHS) county were automatically enrolled into the COHS plan (if their aid code was covered by the plan), even when they were not residing in the COHS county. If a recipient in a non-COHS county was enrolled in a HCP, then this HCP was for the recipient's responsible county. The recipient was not permitted to enroll in a HCP for their residence county. With this enhancement, the residence county can be used to prevent enrollment in the COHS or the non-COHS plan of the responsible county; and allow enrollment in a HCP where the recipient resides. The residence county can also be used for other recipients as well, including Supplemental Security Income/State Supplementary Payments (SSI/SSP) recipients.

The residence county can be updated on MEDS by including the residence county field on online or batch transactions; or by using the new residence address fields on online or batch transactions. Online updating of the residence county (except SSI/SSP recipients) via the EW15 transaction has been available since December 1998 month of eligibility.

For batch transactions, counties may continue to use the existing address fields; no system changes are required by counties as a result of this enhancement. The existing address fields will be stored in the existing primary address fields, but will be used as a mailing address. A new residence address indicator will be set to "N," to indicate that this address is a mailing address, which may or may not be the same as the recipient's residence address. In addition, the residence county will not be updated through batch transactions without the use of the new residence address fields or the residence county field.

Counties may choose to use the new residence address fields by modifying their automated system(s) to send the residence county field on batch transactions or by using the new residence address fields. When the new residence address fields are used, they will be stored in new fields in the primary address segment, and the new residence address indicator will be set to "Y," to indicate that this address is a residence address. When the residence county field is present on the transaction, the MEDS residence county will be updated (if there are no fatal

“Y,” to indicate that this address is a residence address. When the residence county field is present on the transaction, the MEDS residence county will be updated (if there are no fatal errors on the transaction), whether or not the existing or new address fields are included on the transaction. When the residence county field is not present on the transaction, then the residence county will be populated when:

- The new residence address fields are used;
- The residence address passes FINALIST; and
- The residence zip code is within California and is not identified as crossing county lines.

Counties should contact Ms. Dyhana Hamblin, (916) 657-1070, in Information Technology Services Division (ITSD) at least 60 days prior to making changes to their automated system(s) to use the new residence address and other address fields. This lead time is required to enable ITSD to make necessary operational changes and to allow for interface testing with the county.

Overview of the MEDS Address Enhancement

Phase 1 of the MEDS address enhancement included the following items, which were installed in December, 1998:
Modification to the EW15 transaction to update residence county;

- New and modified MEDS inquiry screens to display address and other information:

INQA	MEDS ADDRESS INFORMATION	displays pending and current mailing and residence address, phone number, and residence county;
INQD	CHANGE DATES AND AUTHORIZED REP INFORMATION	displays current authorized representative name and address;
INQE	OTHER CLIENT ELIGIBILITY	displays other client information such as refugee/alien and pickle information;
INQJ	HEALTH CARE PLANS 13 – 15	displays residence county for MONTHS PRIOR each of 13-15th prior months;
INQM	PRIMARY MEDI-CAL/CMSP	displays current residence county;
INQO	OTHER MISCELLANEOUS INFORMATION	deleted;
INQR	RECIPIENT INQUIRY REQUEST INFORMATION	activated option A; added option D; added option E; deleted option O

Phase 1 of the MEDS address enhancement also included the following item, which was installed for March, 1999 month of eligibility:

Modification to the MEDS/county reconciliation process to bypass the address compare logic;

Phase 2 of the MEDS address enhancement, scheduled for July, 1999 month of eligibility, will:

Allow counties to report a mailing address by using the EXISTING address fields in the EXISTING county batch transaction format. This mailing address may or may not be the same as the residence address;

Allow counties to report the pending or current residence address, pending or current mailing address, current authorized representative address, and/or pending, current, or history residence county by using the NEW address fields in the EXISTING county batch transaction format (refer to attached MEDS Data Elements);

Populate the pending or current residence address indicator based on user input. When the user inputs the EXISTING address fields, MEDS will set the pending or current residence address indicator to "N". When the user inputs the NEW residence address fields, MEDS will set the pending or current residence address indicator to "Y";

Standardize the address format on MEDS through the use of a commercial United States Post Office certified software (FINALIST);

Provide an address flag for each pending and current address that is present;

Provide additional values of the address flag to indicate whether this address passed FINALIST, whether a BIC was sent to this address, or whether a BIC was returned from this address (refer to attached MEDS Address Flag Quick Reference);

Allow counties to enter the following address flags to override the value of the address flag generated by MEDS:

- C Address is confirmed by user as mailable; failed FINALIST certification;
- Q Remove existing address;
- 4 Address is undeliverable per source; address not edited by FINALIST
- 8 Homeless client; address not be edited by FINALIST

Allow counties to enter the 9-digit zip code (zip code plus 4 digits) on batch transactions;

Store the address in a standardized format for addresses which pass FINALIST edits;

Store the data elements which can create the postal bar code, including 9-digit zip code, for addresses which pass FINALIST edits;

Store the address as user input for addresses which do not pass FINALIST or are not edited against FINALIST;

Allow the street address of any address to be up to 50 characters in length;

Store pending or current mailing address on MEDS ONLY if it is different from the respective residence address;

Use an address hierarchy to determine which address to use for BIC mailings and Notice of Action (NOA) letters. For the BIC mailings, if current mailing address is present and good, then use this address. Otherwise, if current residence address is present and good, then use this address. Otherwise, if current authorized representative address is present and good, then use this address. Otherwise, do not issue a BIC. For the NOA letters, the same hierarchy is used. However, if a good address can not be found, then the current residence address is to be used;

Indicate on MEDS, with the address flag, which address is used to mail the most recent BIC;

Generate a worker alert when a BIC is re-issued due to a returned BIC ONLY when the recipient has a new or changed mailable current address (see above) and current, ongoing, or pending eligibility in any MEDS eligibility segment;

Populate pending or current residence county from the input transaction, if present;

Populate pending or current residence county, if NOT present on the input transaction, from the county code returned from FINALIST, when the respective residence address passes FINALIST edits, the respective residence zip code is within California, the respective residence address indicator equals "Y" (yes), and the respective residence zip code is NOT identified as crossing county lines;

Use "99" as the pending or current residence county when the respective residence address passes FINALIST edits, the respective residence address indicator equals "Y", and the respective zip code is outside of California;

Maintain the pre-transaction pending or current residence county when the respective residence address is not edited by FINALIST or does not pass FINALIST edits, the respective residence address indicator does NOT equal "Y", and/or the respective residence zip code is identified as crossing county lines;

Provide new worker alert messages for address edits and updates:

Convert all existing MEDS addresses at implementation; those addresses which pass FINALIST edits are to be stored in the new standardized format; those addresses which do not pass FINALIST edits will be stored as entered;

Populate, at conversion, the appropriate value of the address flag, based on the results of the FINALIST edits and whether a BIC has been issued to this address;

Provide current mailing address and residence zip code to the Health Care Options contractor and the health care plans;

Remove the address comparison in the county reconciliation process until this process is modified in future MEDS enhancements;

Future phases include the following functions:

Update MEDS with addresses that are present on the State Data Exchange (SDX) transaction file;

Populate the residence county for SSI recipients from the residence zip code on the SDX transaction file or the EW55 transaction;

Provide the new address fields and lengths for existing online State and county transactions, with one address per transaction;

Modify various existing MEDS inquiry screens to display residence county and a flag to indicate that there are multiple addresses on MEDS for the recipient (subject to space availability on the screen).
