ELIMINATION OF SPECIFIC AID CODES

The purpose of this letter is to announce the elimination of specific aid codes for programs that have expired or been replaced. Counties are being asked to review the aid codes listed below and to reassign beneficiaries in those aid codes to appropriate and updated aid codes. These aid codes will be eliminated as of March 1, 2000.

Programs utilizing Aid Codes 06, 07, 43, 46, 49, 51, 52, 56, 57, 70, 75, 77, 78, and 79 have been replaced or have expired and the aid codes are being terminated from the Medi-Cal Eligibility Data System (MEDS). Before they can be terminated, however, counties must delete approximately 2,200 MEDS records that still have these aid codes with primary, special 1, or special 2 eligibility for the current month. All cases in the above aid codes **must be moved out of those aid codes prior to the March 1, 2000, termination date**. A brief description of each aid code may be found in the enclosure.
