## SOCIAL SECURITY REDUCED CHECKS FOR CERTAIN IN-HOME SUPPORTIVE SERVICES BENEFICIARIES

As you are aware, approximately 16,410 Medi-Cal/Medicare beneficiaries who receive in-home supportive services were notified by the Social Security Administration (SSA) that their November 1999 Social Security checks would be reduced by \$136.50. SSA also told these beneficiaries that the State was no longer paying their Medicare Part B premiums.

This reduction was triggered by a State computer error which inadvertently indicated to SSA that the State was no longer paying (Buying-In) the Medicare Part B premiums for affected beneficiaries. SSA then deducted three months of Part B premiums (\$45.50 per month) from the November checks of these beneficiaries. The State informed SSA that the discontinuance of Buy-In was incorrect and that Medicare premium coverage is to be restored.

The Department of Health Services (DHS) has been working with SSA to expedite the issuance of an SSA refund in the amount of the reduced November payment. DHS sent these beneficiaries a letter on November 1, 1999, explaining the situation and what is being done. Because counties have asked for a copy of that letter, we are providing that copy as an enclosure to this letter.
