IMPROVING COMMUNICATIONS BETWEEN COUNTY WELFARE DEPARTMENTS (CWDs) AND SOCIAL SECURITY ADMINISTRATION (SSA) FIELD OFFICES

The purpose of this letter is to transmit to CWDs the list of approved CWD and SSA contacts to be used for problem resolution. Also enclosed is a copy of the letter SSA sent to their field offices (FOs) informing the FOs of the designated contacts at each CWD to be used to resolve Medi-Cal problems for the Supplemental Security Income/State Supplementary Payment population.

Medi-Cal Eligibility Branch staff met with SSA staff in December 1994. As a result of that meeting, both agencies agreed to compile a "contact person" list to be exchanged between the agencies to help enhance lines of communication. Individuals on these lists should be contacted by the respective agency to assist the technical staff in both agencies to resolve problems that require more than routine research.

As indicated in the SSA letter, Department of Health Services (DHS) encourages management staff at all CWDs to meet with their counterparts at SSA to discuss the types of situations which will require communication with the SSA liaison. Both agencies will periodically update the liaison list and reissue as needed. In order to maintain correct names and telephone numbers, it is important for the CWDs to notify both DHS and their local SSA field office of future changes.

Please do not give the SSA liaison's name or phone number to the public. These persons may only be contacted by the corresponding agency liaison for those cases which need assistance from the SSA for the proper benefit issuance.

DHS also encourages periodic meetings between the CWDs and the local SSA field office staff to facilitate and increase communication between the agencies.

INFORMATIONAL to FOS OUTSIDE CALIFORNIA

As we told you in December, the California Department of Health Services (DHS) and Social Security Administration have agreed to provide their respective local offices with appropriate contact persons to enhance lines of communication at local levels.

Attached is a list of names and telephone numbers of contact persons in each county welfare office in California. These people have been designated to work with counterparts in local SSA field offices to resolve Medical and/or Medical Eligibility Data Systems (MEDS) problems. Also attached is the corresponding list of SSA's Medical liaisons for field offices in California. For Medical-related situations which cannot be resolved in routine contacts between technical staffs in the local offices, these are the people who should intervene. The telephone numbers should not be given to the general public.

Managers are encouraged to meet with the county liaisons to discuss the types of situations, and under what circumstances, the respective offices should contact each other. DHS will be encouraging its county liaisons to do the same thing. DHS and SSI Programs will periodically update the liaison lists, but it is obviously more important to keep each other informed of staff or telephone number changes at local levels. We hope that you and your staffs will take this opportunity to establish and maintain a closer relationship with your counterparts in the counties.

As an example of the results we have had at the regional level through regular meetings with DHS, we have established a pilot in four SSA FOs that could lead to all CA FOs having direct query access to MEDS information, with the possibility of eventually having query access to other State data systems, such as state unemployment and disability benefits, and state tax information. In addition, we are well on the way to setting up more effective methods of identifying SSI recipients who are admitted to title XIX facilities, and for providing electronic verification of SSNs for the CA Department of Motor Vehicles.

This memorandum is informational to FOs outside California. This type of mutual exchange of information can be useful, however, for all FOs, and if problems cannot be resolved locally, please contact us.
