REGIONAL TRAINING ON ARTICLE 9J -- PROPERTY HELD IN TRUSTS

The purpose of this letter is to inform you that we have selected six county sites for regional training sessions on the revised/new Medi-Cal Eligibility Procedures Manual Article 9J - Property Held In Trust. The training will focus on the changes to the treatment of trusts and annuities based on the implementation of OBRA '93, the treatment of Medicaid Qualifying Trusts, and all other trusts.

We have designated dates for the regional training sessions and would like to invite you to attend one of the following sessions. Training will be conducted by State staff from the Medi-Cal Eligibility Branch (MEB).

DIRECTIONS

COMING FROM THE SACRAMENTO AREA:

Head south on Highway 80. Take Highway 680 toward Walnut Creek/San Jose. Cross the Benicia Bridge and just past Martinez, take Highway 4 west toward Richmond. Immediately take the Pacheco exit and turn left at the bottom onto Pacheco Blvd. Turn left onto Arnold Drive and go up the hill. The Training Institute is located in the Summit Centre on your left.

COMING FROM THE SAN JOSE AREA:

Head north on Highway 680 toward Walnut Creek. Stay on Highway 680 past the city of Concord. At the Highway 4 interchange, take Highway 4 west toward Richmond. Immediately take the Pacheco exit and turn left at the bottom onto Pacheco Blvd. Turn left onto Arnold Drive and go up the hill. The Training Institute is located in the Summit Centre on your left.

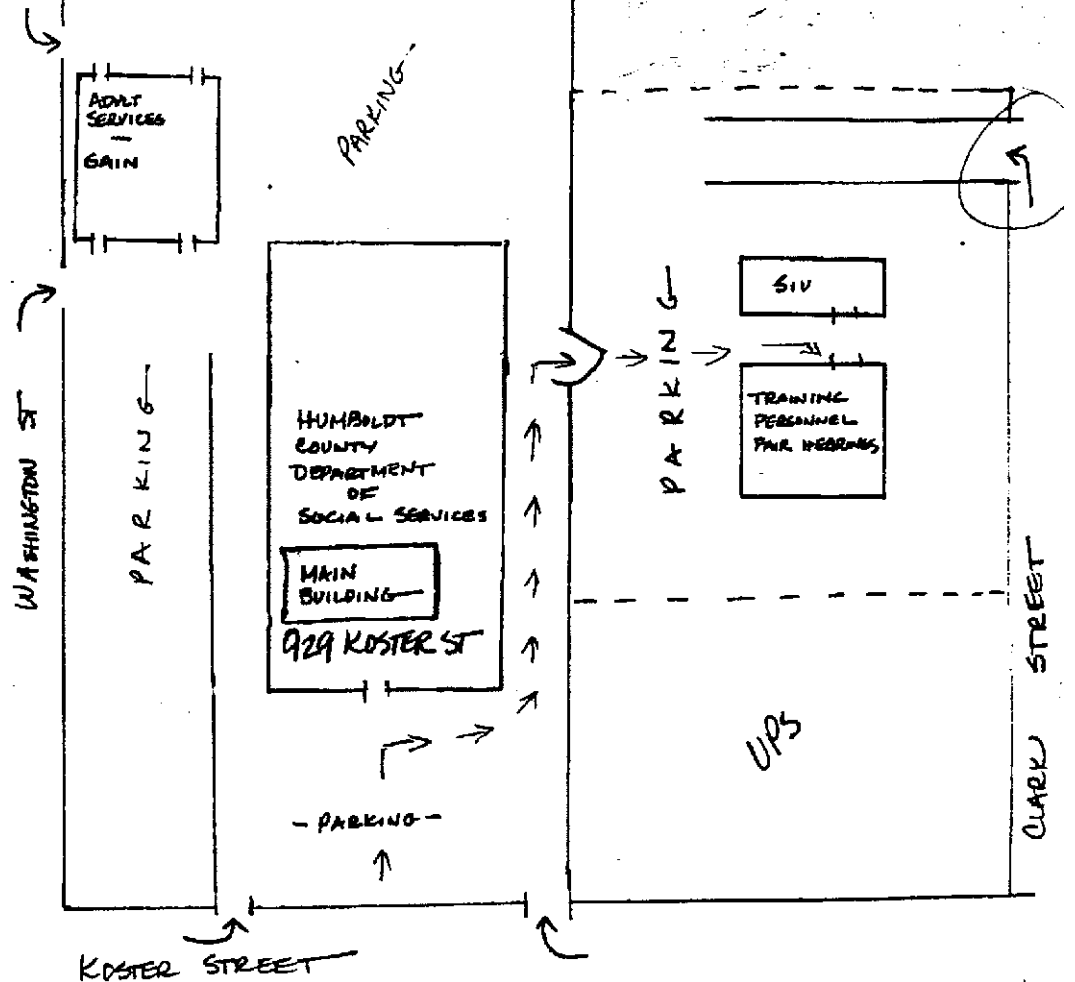
COMING FROM THE STOCKTON AREA:

Take Highway 4 toward Richmond. Immediately past the Highway 4/680 interchange, take the Pacheco exit and turn left at the bottom onto Pacheco Blvd. Turn left onto Arnold Drive and go up the hill. The Training Institute is located in the Summit Centre on your left.

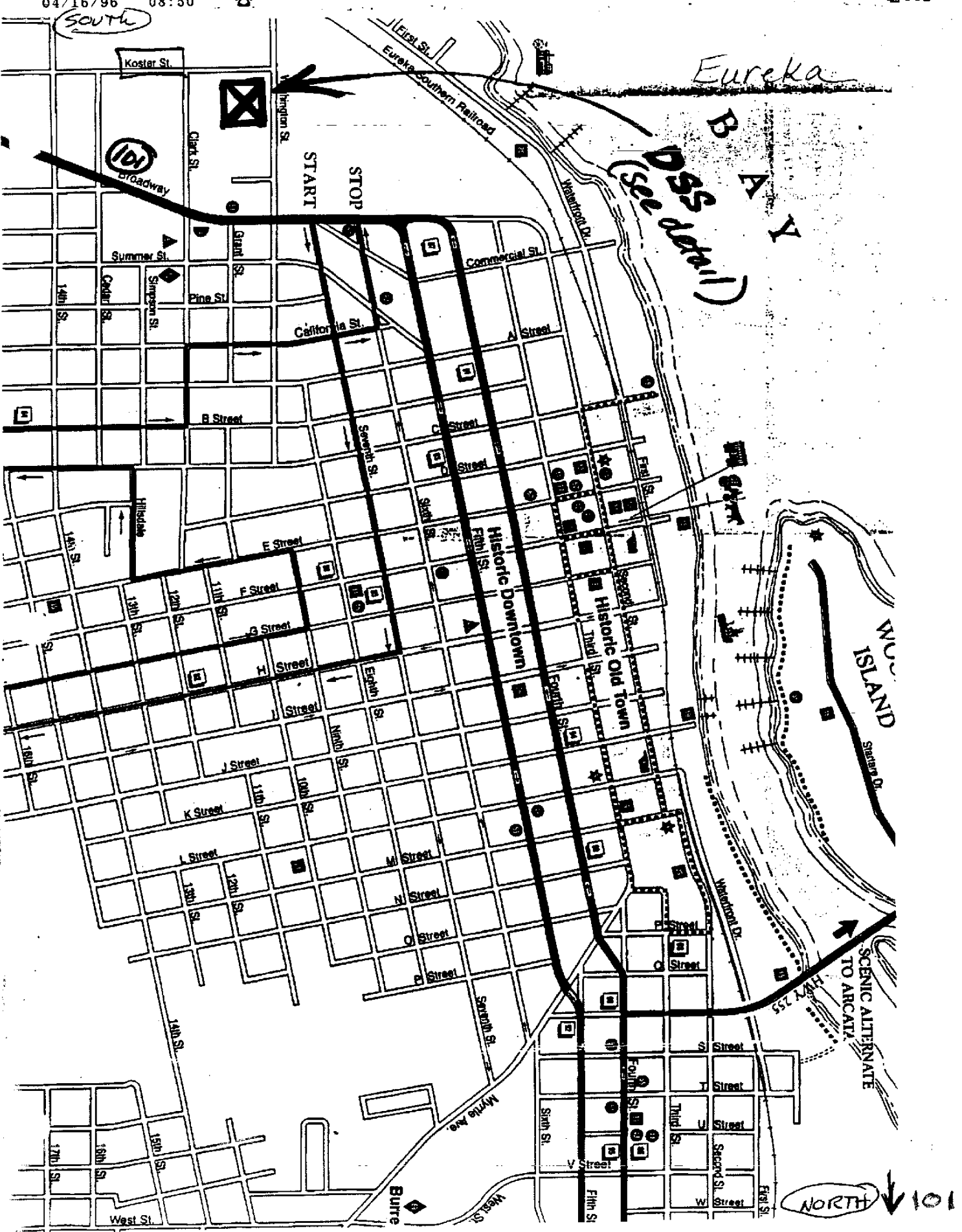
COMING FROM THE RICHMOND/SANTA ROSA AREA:

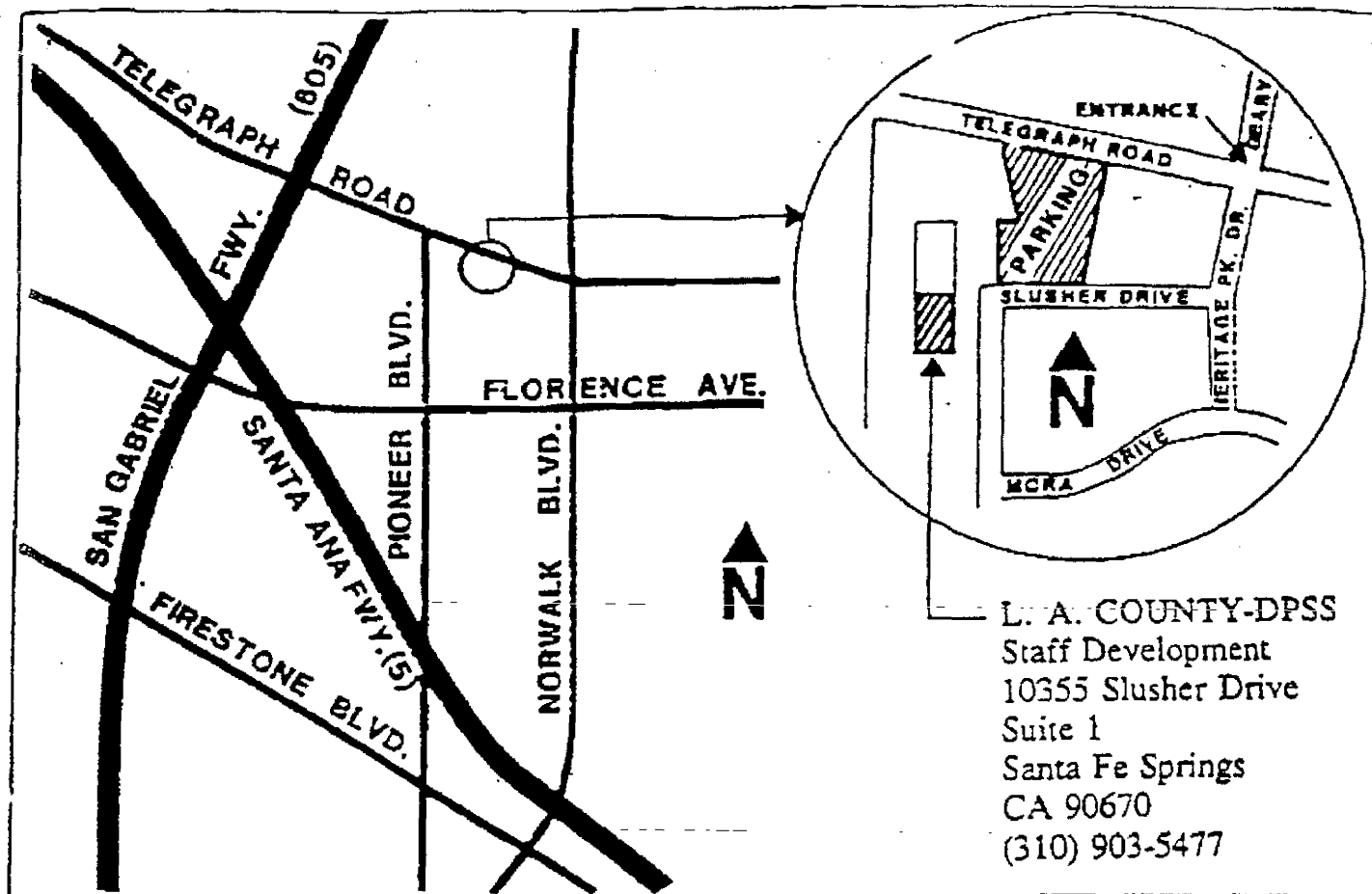
From Highway 80, take Highway 4 east toward Martinez/Stockton. At Martinez, take the Morello Avenue exit. Turn left at the bottom onto Morello and cross under the freeway.
