STRATEGIES TO ADDRESS IDENTIFIED HOUSING AND SERVICE GAPS IN THE COUNTY
<p>County Narrative Description (200-word limit)</p> <p>Anthem Blue Cross and California Health & Wellness partnered with the Central Sierra CoC lead agency, Amador-Tuolumne Community Action Agency (ATCAA) to develop the HHIP County LHP for Calaveras County. MCP strategies to address identified housing and service gaps align with the CoC's multi-year "Strategic Action Plan to Prevent and End Homelessness" to reduce homelessness in Amador, Calaveras, Mariposa, and Tuolumne counties, focused on strengthening administrative capacity, increasing housing placements, and preventing persons from homelessness, and HHAP-3 strategies on reducing returns to homelessness, and increasing placements from street outreach.</p> <p>The MCP's are aligning with broader community strategies, HHIP strategies, and will focus on 1) data sharing/HMIS access; 2) integration with CES, 3) partnerships with street medicine programs; 4) addressing health disparities, and 5) ensuring strong implementation of CalAIM ECM and Community Supports housing services. Lastly, based on CoC gaps, there is a desire to use a portion of the funds to expand utilization of HMIS/CES and implement new street outreach services.</p> <p>Anthem and California Health & Wellness will collaborate with ATCAA and the CoC throughout the program to implement MCP strategies, meet HHIP program measures, and create robust housing and healthcare partnerships that address homelessness in Calaveras County.</p>
