### STRATEGIES TO ADDRESS IDENTIFIED HOUSING AND SERVICE GAPS IN THE COUNTY

#### County Narrative Description (200-word limit)

CalViva Health and Anthem Blue Cross are committed to collaborating to reduce and prevent homelessness in Fresno County and enhance the connection of Medi-Cal members to housing services. To build consensus around strategies and gain community input for our Housing and Homelessness Incentive Program (HHIP) County Local Homelessness Plan, MCPs jointly met with members of the Fresno-Madera CoC (FMCoC), the local CoC, and presented proposed strategies at CoC meetings and stakeholder forums. This allowed us to engage multiple community stakeholders (i.e. government representatives, social service and housing agencies, and providers) and ensure alignment with Homeless Housing, Assistance, and Prevention Round 3 (HHAP-3) strategies and FMCoC's 2-Year Strategic Plan.

Our countywide strategies include: 1) improve data sharing capabilities with Homeless Management Information System (HMIS); 2) integrate with Coordinated Entry System (CES); 3) develop partnerships that address disparities and inequities in housing-related service delivery (i.e. an integrated and robust street medicine model); and 4) bolster ongoing CalAIM Community Supports and ECM initiatives to better identify and serve individuals experiencing homelessness. MCPs and FMCoC will work together to implement strategies, meet HHIP measures, and create capacity and partnerships to make progress toward racial equity and addressing

homelessness and housing insecurity in Fresno County.
